Madam / Sir,

With reference to the subject cited above, the allotment order of Rice and Milled Arhar Dal for eligible beneficiaries under the **State Food Security Scheme (SFSS)** in view of **COVID-19** for the month of **April-2020, May-2020 & June-2020** issued by FS & CW Department, Odisha, Bhubaneswar is enclosed for necessary distribution. A stock of Q. 3.15 of rice and Q. 0.24 of Milled Arhar Dal for the month of **April-2020, May-2020 & June-2020** from Central Pool is to be distributed among the beneficiaries under SFSS as per the enclosed statement.

SFSS beneficiaries are entitled to get additional **5(five) kilograms** of rice per person per month & **01(one) kilogram** of Milled Arhar Dal per family per month on free of cost.

Distribution of above stocks at FPS point should be made only through E-PoS Device without bio-metric scanning through finger print/IRIS scanner wherever PoS device has been delivered to the FPS. Sales through manual mode should be discouraged as far as practicable. However, in case of any exigencies or in worst circumstances, such manual mode of distribution should be resorted to only after due approval of concerned BDO/EO with proper justification. In such case, the stock/sales records must be kept for future reference/verification & the physical balance should be entered by Marketing Inspectors in the FPS portal for the concerned Fair Price Shop (FPS) at the end of the distribution.

The following instructions may be followed strictly for ensuing meticulous distribution among eligible beneficiaries.

1. Per card entitled of rice and dal shall not be reduced below the prescribed allotment. Minimum 25% verification of sale will be conducted by the Inspector of Supplies/ACSO in charge of the Block / ULB.
2. The distribution of rice and dal shall be undertaken as per the dateline mentioned in the table during which all the dealers will keep their shops open and keep sufficient stock for the consumers.
3. The door step delivery of allotted quantities of food grains by the concerned Transport Contractor (Level-II) to the respective FPS dealer shall be ensured sufficiently in advance by the concerned Procurement Inspector / Inspector of Supplies / Marketing Inspector before the dates of distribution.
4. Certificate of GPLAC or WLAC will be obtained on proper distribution of food grains every month and submitted to the BDO / Sub-Collector / ADM with counter signature of Inspector of Supplies / ACSO as per Annexure-1 of DSS Guideline

You are requested to ensure distribution of food grains to the genuine Ration Card holders.




