
Madam / Sir,

With reference to the subject cited above, the allotment order of Rice & Whole Chana under State Food Security Scheme (SFSS) for the month of July-2020 & August-2020 issued by FS & CW Department, Odisha, Bhubaneswar, is hereby re-allotted for necessary distribution. A stock of Q. 1334.10 of rice and Q. 83.50 of whole chana for the month of July-2020 & August-2020 from Central Pool is to be distributed among the eligible beneficiaries under the State Food Security Scheme (SFSS) as per enclosed statement.

The scale of distribution of additional rice under State Food Security Scheme (SFSS) is 05 Kgs per person per month and 1 kg of whole chana per family per month on free of cost.

The above allotted PDS stocks should be released on to those Fair Price Shops (FPSs) which have valid FPS license / renewal for the Financial Year 2020-21 (till March-2021). Lifting and distribution of above allotted PDS should be started as per the timeline fixed in the table.

Distribution of Rice and Wheat at FPS point should be made only through e-PoS Devices without bio-metric scanning through finger prints/IRIS scanner wherever PoS device has been delivered to the FPS. Sales through manual mode should be discouraged as far as practicable. However, in case of any exigencies or in worst circumstances, such offline / manual mode of distribution should be resorted to only after due approval of concerned ADM, BDO/EO or CSO with proper justification. In such case, the distribution data must be synced to Odisha FPS server as and when network connectivity is available to e-PoS or by the last day of distribution.
