Madam / Sir,

With reference to the subject cited above, the FPS & Block/ULB wise allotment rice under Annapurna Scheme for the month of **September-2020 & October-2020** is hereby made as per the number of Annapurna beneficiaries and enclosed herewith as Annexure-I, II, III, IV. The allotted stock of rice is to be distributed to the Annapurna beneficiaries @ 10 kg per month on free of cost. A stock of **Q.57.80** of rice is to be distributed among the Annapurna beneficiaries for the month of **September-2020 & October-2020** as per the enclosed statement.

Distribution of Rice under the Annapurna Scheme at FPS point should be made only through E-PoS Device along with NFSA, SFSS Rice & PHH Wheat. However, in case of any exigencies or in worst circumstances, manual mode should be resorted to only after due approval of concerned BDO/EO with proper justification and the stock account must be entered in RCMS Centre at the end of the distribution for generation of Closing Balance.

After completion of distribution of Annapurna rice stock, Utilization Certification shall be submitted to the undersigned positively for onward transmission to Govt.
