ADDENDUM TO RFP No. 4904/ Dt. 21.08.2021 and Notice No 362 Dt. 23.08.2021

- In order to strengthen the security of ERONET System Election Commission of India has directed to implement the restriction of access to ERONET from whitelisted IP address only by 15th September, 2021. The whitelisting of IP address require fixed IP address(es) from where the system is being accessed this requires either internet leased line or Broadband/ FTTH connection with fixed IP Address.
