



ADDENDUM TO RFP No. 4904/ Dt. 21.08.2021
and Notice No 362 Dt. 23.08.2021

In pursuance to Corrigendum No 5050 Dt. 27.08.2021 and No. 5471 Dt. 13.09.2021 of the Home (Elections) Department, Odisha, Bhubaneswar the following points are added in the RFP No. 4904/ Dt. 21.08.2021 and Notice No 362 Dt. 23.08.2021 of th District Election Office, Boudh.

1. In order to strengthen the security of ERONET System Election Commission of India has directed to implement the restriction of access to ERONET from whitelisted IP address only by 15th September, 2021. The whitelisting of IP address require fixed IP address(es) from where the system is being accessed this requires either internet leased line or Broadband/ FTTH connection with fixed IP Address.
2. As per Annexure-I-A of the RFP No. 4904/ Dt. 21.08.2021 and Notice No 362 Dt. 23.08.2021 of the District Election Office, Boudh the bidder will have to give an UNDERTAKING/ CERTIFICATE that the bidder will ensure establishment of operation center(s) at the Sub-Division dedicated manpower before signing of the agreement to execute the RFP related works. Headquarters with the availability of prescribed infrastructures.
3. In addition to the ten items prescribed the bidder will ensure whitelisted IPs to access ERONET as per the guideline of ECI communicated vide Letter No. 485/Comp/ERONet/Security/2021/IT-III Dt. 03.09.2021 (copy enclosed).
4. The bidders who have already submitted their bids will be allowed one more week time to submit revised bids to facilitate there to accommodate the cost of fixed IP Plan.
