Perused the Judgment in MVAA No.142/2017.Heard the counsel of the applicant.There was serious objections from travelling public against the curtailment of morning trip from Omassery at 5.40am to Koyilandy.This will deprive the limited travelling facility of the public during morning from Omassery to Koyilandy and evening one round trip to Thiruvambady.The proposal is overall against the interest of the public.Hence rejected.

This application was considered formerly through circulation on 30-11-2017 and in RTA dtd.4-10-2017.The major objection raised was there is violation of scheme by overlapping from city to CH overbridge and Mavoor Jn to CH over bridge.Both have 200 metres long.This overlapping in no way affect the operation of KRTC.But KSRTC objected this application vehemently.Another enroute operator also objected this application on the basis of various reasons including reduction of income of his operation.But the variation sought for is connecting Railway station with Moffussil Bus stand,KSRTC and Beach Hospital with Railway station..This will be highly beneficial to the travelling public especially for passengers who have to connect Mofussil stand, KSRTC stand and Beach hospital. Where as the objection of the KSRTC is legally sustainable eventhough factually it is not affecting operation of any KSRTC.This variation as it is connecting Railway station to KSRTC will one way compliment the operation of KSRTC.However RTA can decide only on the basis of the provision of the law only.Hence application is **rejected**.

Item No.75

This is an application for fresh permit on the route Bepore-Pulimoodu-Naduvattam-Thamburan Road-Marad-Payyanakkal-Niveditha corner-Chullikkad Jn-Puthiappa.Perused the Judgment in MVAA No.248/2017 and heard the counsel of the applicant.This is a reconsideration of the application on the basis of the order of Hon'ble STAT.The application was

rejected on the basis that the entire route is in city limit. However the Hon'ble STAT observe that " The field officer reported that the route sought by the petitioner is a new route with three virgin portions and grant of permit is beneficial to travelling public. The 1st respondent rejected the application as per the impugned order stating that the route lies in city limit and in view of the Sec.71(3) of the Act, the application is rejected. The field officers report says that even though the entire route falls within corporation limits , major portion of the proposed route traverses through ill served coastal areas inhabited by poor fisher folks. The route traverses through ill served coastal area cannot be treated as city. This aspect was not considered by the 1st respondent."

The total number of stage carriage permits in the city was limited in the year 2000 as 400 numbers by the Government. It is obvious that owing to surrender of city permits by various operators , there are vacancies in this 400 numbers and there is no question of exceeding the number of permits in city as restricted by Government. More over the observation of the Hon'ble STAT is to consider this route as it is a new one with 3 virgin portions and not as a city route. The field officer reported that the route is highly beneficial to ill served coastal public. Hence the application **Granted** subject to settlement of timings and production of road fitness for the virgin portion fro PWD.
