This is an application for fresh regular stage carriage permit in respect of S/C KL 58 G 7115 to operate on the route Kurumpoyil – Koottalida – Balussery - Kozhikode (via) Kannadipoyil, Arapeedika, Manhapalam, Nanmanda, Eranhipalam, Baby Memorial hospital. “Heard. Perused the judgment in MVAA No. 29/2018 Dtd15.03.2018 of Hon’ble STAT Ernakulam. Considered the application in the light of order of the Hon’ble STAT. The length of the route is 44 Kms and if the application allowed though Eranhipalam, Nadakavu and Mavoor Road Junction there is an overlap of 5 Knms on nationalized route which is more than 5% the total route length. Hence violation of scheme vide Notification No.42/2009/Tran Dt. 14.07.2009. Hence application for fresh regular stage carriage permit is **rejected**.

The field officer reported that the introduction of new service is beneficial to traveling public on the remote places at Vayalad and Manichery. This is a regular need for stage carriage and the applicant can obtain a regular stage carriage permit for 5 years. But the section 87(1) c in which the permit is sought for specific temporary need as provided in the section. RTA cannot issue temporary permit U/s 87(1) c on a route with a permanent need. Applicant is directed to remit fee for regular stage carriage permit and

apply for permit U/s 70. The present application for temporary permit U/s 87(1) c is **rejected**.

There is a Writ appeal before the Division Bench of Hon'ble High Court of Kerala against the variation on saved permit and KSRTC argued that on the basis of Notification in G.O (P) No.8/2017 and there is an order of status quo. Hence **adjourned** the application with direction Secretary RTA to place before the next RTA with specific remarks.
