FORM OF PRELIMINARY NOTIFICATION TO BE ISSUED BY THE COLLECTOR UNDER
SUB-SECTION (1) OF SECTION 11

WHEREAS, the District Collector, Kozhikode as per Order No. DCKKD/12473/17/B4, dated 7-10-2017 has appointed the Special Tahsildar (LA), KCRIP, Kozhikode to perform the functions of a Collector for the purpose of land acquisition under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013;

AND WHEREAS, the Government hereby appoint Deputy Collector as Administrator, for the purpose of rehabilitation and resettlement to the proposed acquisition;

AND WHEREAS, it appear to the Government that the land specified in the schedule below is needed or is likely to be needed for a public purpose to wit for widening of Bell Mouth to Panaththazham-CWRDM Road at Manathanath Thazham;

Now, THEREFORE, notice is hereby given to that effect to whomsoever it may concern in accordance with the provision of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

All person interested in the said land are accordingly requested to lodge before the Special Tahsildar (LA), KCRIP, Kozhikode within 15 days from the date of publication of the above notification or after giving a public notice regarding this whichever is later a statement in writing of their objections if any regarding the updation of land records or title in respect of the land proposed for acquisition. Any objection/statement which is received after the due date or which does not clearly explain as to how the objector is interested in the land is liable to be summarily rejected.
