SHORT NOTICE INVITING EXPRESSION OF INTEREST

Expression of Interest (Eoi) is hereby invited from reputed firms of Lohit District for sales / Supply of the horticulture inputs or other inputs as may be required in implementation of Horticulture programmes during 2018-19 to the selected beneficiaries / Horticulture department.

The following self attested documents should be enclosed.

01. Valid trading License.
02. Showroom photographs with geo-tagged location.
03. Dealership certificate of items deals with price list.
04. GST Registration.
05. Bank Account No. of the firm supported by a cancelled Cheque leaf.
06. Bank solvency certificate.
07. No dues certificate from Apex Bank.

The above documents should be submitted in cover No. 1 and should be super-scribed as "**TECHNICAL BID**." It should be properly sealed and addressed to the District Horticulture Officer, Lohit District, Tezu.

The interested local firms should quote their prices in the format for expression of interest and submit in cover No.2 in sealed pack address to the District Horticulture Officer, Lohit District, Tezu. The cover No. 2 should be super scribed as "**FINANCIAL BID**".

The expression of interest paper for items with details specification / measurement etc. may be obtained from the Office of the District Horticulture Officer, Lohit District, Tezu during working days w.e.f 01-03-2019 to 08-03-2019 on payment of Rs. (Rupees Two Hundred) only. Both the cover -1 & cover -2 should be inserted in a single Big cover along with a letter referring this Notice and addressed to the District Horticulture Officer, Lohit district, Tezu.

The Eoi should reach to the office of the District Horticulture Officer, Lohit District, Tezu on or before 08-03-2019 at 1500 hours.


OPENING OF SEALED COVERS:

Both the sealed covers i.e cover-1 (Technical bid) and cover-2 (Financial bid) will be opened by the District Level Board constituted by the Deputy Commissioner, Lohit District, Tezu.

The Financial bids in respect of those firms whose technical bids are qualified will only be opened. The firms with authentic documents will be selected & recommended by the Board as sources of inputs for the beneficiaries and the department of Horticulture.

TERMs & CONDITiONS


1. To encourage the local Entrepreneurs as envisaged in "the Arunachal Pradesh District Based entrepreneurs and professionals (incentives, development and Promotional) Act, 2015", the firms within the Lohit district of Arunachal Pradesh shall only be qualified to participate in the Notice inviting Expression of interest (NIEI)
2. The firm should have valid trading license having relevant trade items issued by Deputy Commissioner.
3. The items enlisted in the format are tentative. The final procurement of items will be as per the final sanction order. The rates quoted by the firms should be inclusive of all taxes and transportation / freight charges.
4. The firms should supply / sale the inputs to the beneficiaries / department as per the specification illustrated in the Annexure – 'A' of the NIEI.
5. The rates quoted by the firms should be valid for the financial year 2018-19.
6. The firms must have GST registrations and Tax applicable from time to time shall be deducted at source as per GST guidelines.
7. In case of any information provided by the firm in both Technical and Financial Bids are found to be factually false or misleading , such firms will be summarily rejected at any time and liable for penalties as applicable.
8. In case of any disputes, the court at Tezu shall only have the jurisdiction.
9. The District Horticulture Officer, Lohit District, Tezu reserves the right to accept or reject the NIEI without any notice reasons.
