Therefore, all the Committee members of Religious places/places of worship are hereby directed to follow above Govt instruction strictly failing which necessary legal action will be initiated against the defaulters under section 51 to 60 of the Disaster Management Act,2005, Arunachal Pradesh Epidemic Disease(Prevention of COVID-19) Regulations, 2020, U/S 188 in the Indian Penal Code,1860 and other relevant sections of Epidemic Disease Act and other laws.


