Government of India has received a credit from the International Development Association (IDA) in various currencies equivalent to US\$ 236 Million towards the cost of the FIMSUL **II** UNDER **COASTAL DISASTER RISK REDUCTION PROJECT** and intends to apply part of the proceeds of this credit to eligible payments under the contract for which this invitation for quotations is issued.

3. **Bid Price**

- a) The contract shall be for the full quantity as described above or +/- 10% of the quantity variation as decided by the Joint Director of Fisheries (Regional), Nagapattinam. Corrections, if any, shall be made by crossing out, initialing, dating and re writing.
- b) All duties, taxes, GST and other levies payable if any in connection with this Bid shall be shown separately.

- c) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
 - d) The Prices shall be quoted in Indian Rupees only. It is requested to fill the BID PRICE in the Letter Pad of the firm.
 - e) Bid Price format model is enclosed for easy reference.
4. Each bidder shall submit only one quotation. Bidder shall not contact other Bidders in matters relating to this Quotation.

5. **Validity of Quotation**

Quotation shall remain valid for a period not less than 30 days after the deadline date specified for submission.

6. **Evaluation of Quotations**

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

(a) are properly signed ; and

(b) Confirm to the terms and conditions, and specifications.

The Quotations would be evaluated for the Lot wise.

GST if any in connection with this Bid shall not be taken into account in evaluation, but eligible to get the same once the contract is awarded.

7. **Award of contract**

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive for the qualification expected and who has offered the lowest evaluated quotation price.

7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract. The decision of the Employer is the final.

7.2 The bidder whose bid is accepted will be notified for the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

8. **Rectification**

After completion of supply and installation, before issue of satisfaction certificates by the fisheries department, if any discrepancies are found, the contractor should rectify the same at free of cost.

The Department of Fisheries reserves the right to check the quality and reject any Goods if found unsuitable.

The rejected Goods, if any, will have to be replaced by good quality Goods forthwith at the risk of the Contractor. No payment will be made for the rejected Goods.

9. **PAYMENTS:-**

Payment with GST shall be made within 30 days after getting satisfaction certificates.

Normal commercial warranty of two years shall be applicable to the supplied goods.
