



**OFFICE OF DISTRICT MAGISTRATE, AMRITSAR**  
**(COVID-19 CONTROL ROOM)**

**ORDER**

It has been brought into the notice of undersigned today by Civil Surgeon, Amritsar vide the office letter No. IDSP/877-880 Dated 15.09.2020 that six active positive cases of Covid-19 have been confirmed in Gali No. 7A, Karpura area and as per protocol and advisory received from Ministry of Health and Family welfare, Government of India, it appears to me that these cases can affect the surrounding areas and possess a potential threat to nearby localities.

Now, therefore, I, Dr. Himanshu Aggarwal, IAS, Additional District Magistrate, Amritsar by virtue of the powers vested in me under the Disaster Management Act/Epidemic Diseases Act, declare **Gali No. 7A, Karpura area of District Amritsar as a Micro Containment Zone** for checking the further spread of COVID-19.

This order shall take effect at once.

Whereas, to deal with the situation and effective implementation of the Containment measure, following tasks are assigned to officials mentioned below:-

1. **Sub Divisional Magistrate Amritsar-2 :-**

- Will be the Supervisory officer to carry out the administrative control of the area under containment with a purpose of breaking chain of transmission and thus preventing its spread to new areas,
- Will be responsible for posting signs and create awareness informing public about the perimeter control.
- Will be responsible for the field staff brought in for surveillance activities and that for providing perimeter control.
- Will be responsible to update district control cell with provision of real time and consolidated data on designated interval.
- For supply of essential commodities in the area.

2. **Area-Incharge Assistant Commissioner of Police:**

- Implementation of social distancing measures and cordoning off the area under containment sealing all the entry and exit points. The perimeter control will ensure that there is no unchecked outward movement of population from containment zone except for maintaining essential services.
- An official will be deputed at these entry points to keep a record of anybody entry or exiting the points.

3. **CMO/SMO/Civil Surgeon and their staff of Health Department:**

- Responsible for 100% testing of all people in the zone, providing necessary medical facilities within 3 days of declaration of the Zones.
- Establishing surge capacities for isolating all suspects/ confirmed for medical care.
- Active surveillance carried out daily through ASHAs/Anganwari Workers/ANMs.
- They will line list the family members and those having symptoms, the field worker will provide mask to the suspect and to the care giver identified by the family.
- The healthy workers will be posted at the exit point of the area under containment and will perform screening (interview travellers, measure temperature, record the place and duration of intended visit and keep complete record of intended place of stay).
- All vehicles moving out of the perimeter will be decontaminated with sodium hypochlorite (1%) solution.

4. **District Mandi Officer through Secretary Market Committees:**

- Providing the uninterrupted supply of the vegetables and fruits in the area under Containment Zone.


5. **Joint Commissioner, Municipal Corporation:**

- Providing water supply and necessary sewerage facilities in the area under respective jurisdiction along with sanitisation of the area.

6. **Department of Food Supplies & Consumer Affairs (DFSC through DFSO/AFSO) :**
- Providing the uninterrupted supply of the Food items and consumable in the area under containment.
7. **PSPCL through SDO/SDE/JE:**
- Providing the uninterrupted Power supply to area under containment and treatment facility.
8. **PPCB through SDO/JE:**
- As large quantity of bio-medical waste is expected to be generated from Micro containment zone. the official will be responsible for discarding this bio-medical waste by utilizing the bio-medical waste management services at the designated hospitals.
9. **Department of Animals Husbandry:**
- Providing uninterrupted supply of Animal fodder. Ensure deputing a veterinary doctor to take care of the health of domestic animals.

The department heads in the district of all the departments as mentioned will ensure round the clock duties for carrying out the above responsibilities and will be required to submit the roster of duties with contacts details of the officials in advance to the control room office for effective control.

These institutions/officers/employees will follow the instructions/orders issued by Government of India/Govt. of Punjab and undersigned, as issued from time to time regarding the Covid-19. **Sub Divisional Magistrate, Amritsar-2 shall be the overall in charge of Containment operations in Gali No. 7A, Karpura area of District Amritsar.** He along with the Assistant Commissioner of Police and the Surveillance incharge doctor, will immediately visit the area and ensure the barricading on all entry and exit points as per the location of sites where cases have been found.
