**(COVID-19 CONTROL ROOM)**

**ORDER**

1. Whereas, in exercise of powers under the Epidemic Diseases Act, 1897, The Government of Punjab has already issued the Punjab Epidemic Disease, COVID-19 Regulations, 2020 for the containment and prevention of the spread COVID-19.
2. Whereas, the latest guidelines have been received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide letter no: SS/SCSH/2020/592 dated 17-8-2020 regarding additional restrictions to be imposed within the Municipal limits in all cities of Punjab.
3. Whereas, in continuation of the orders issued regarding Unlock 3.0 vide letter no: COVID-19/3005-3014 dated 1.8.2020 and in exercise of the powers conferred under the rule 12 of the Punjab Epidemic Disease, COVID-19 Regulations, 2020 and Section 144 of Cr. P. C. 1973, I Gurpreet Singh Khaira, IAS, District Magistrate, Amritsar, hereby issue this order within the Municipal limits of Amritsar.

The following additional restrictions shall be in place:

**i. Night Curfew (09:00 pm to 05:00 am)**

Movement of the individuals for all the non-essential activities shall remain prohibited between (09:00 pm to 05:00 am) within the Municipal limits.

However, essential activities including operation of multiple shifts, movement of persons and goods on National and State Highways and unloading of cargos and travel of persons to the destination after disembarking from buses, trains and Aeroplanes will be permitted.

Similarly, all Industries running into 2-3 shifts will also remain open.

**ii. Restrictions on timings**

- Restaurants, Hotels and other Hospitality Units till 08:30 pm
- Shops and Shopping Malls till 08:00 pm.
- Restaurants/Hotels situated within the Shopping Malls till 08:30 pm.
- Liquor vends till 08:30 pm.

iii. **Stay safe at home**

Shopping Malls throughout the city limits are to be remain closed on Sundays as per the guidelines dated 31.07.2020.

These orders shall take immediate effect and will be applicable till further orders.
