### ORDER

In continuation of this office order issued vide letter no./COVID-19/4790-4810 dated 15.12.2020 vide which night curfew and restrictions for COVID-19 were imposed upto 31st December, 2020 in district Amritsar and as per latest guidelines received from Government of Punjab, Department of Home and Justice vide letter no. 7/56/2020/2H4/5067 dated 24.12.2020 (copy enclosed), considering the religious festivities no night curfew restrictions (10 pm to 5 am) throughout the district, shall be applicable on 24.12.2020 for devotees intending to visit Churches on Christmas eve.

The organisers in the respective churches shall strictly ensure observance of the COVID-19 appropriate behaviour including restrictions on indoor (100 persons) and outdoor (250 persons) social gatherings, wearing of face masks, social distancing norm (minimum 6 feet distance between 2 persons) and frequent hand-wash/sanitizing.

**Sub:** Additional restrictions to be implemented upto 31st December 2020 due to COVID-19 pandemic – Relaxation in night curfew on 24<sup>th</sup> December 2020 in entire State and on 25th to 27<sup>th</sup> December 2020 in Fatehgarh Sahib in view of religious festivities.

1. In continuation of this office letter No.7/56/2020/2H4/4856 dated 14th December, 2020 (copy attached for ready reference) vide which night curfew and restrictions for Covid-19 appropriate behaviour were imposed upto 31<sup>st</sup> December, 2020
2. In view of the religious festivities, the following relaxations in the Night Curfew (10 pm to 5 am) are allowed:-
  - (i) No Night Curfew restrictions (10 pm to 5 am) throughout the State, shall be applicable on 24.12.2020 for devotees intending to visit churches on Christmas eve.
  - (ii) No Night Curfew restrictions (10 pm to 5 am) restrictions on 25th, 26th and 27th December 2020 in District Fatehgarh Sahib to enable the devotees intending to visit Gurdwaras in view of Shaheedi Jor Mela .
3. The organisers in the respective churches and Gurudwaras shall strictly ensure observance of the Covid-19 appropriate behaviour including restrictions on indoor (100 persons) and outdoor(250 persons) social gatherings, wearing of face masks, social distancing norm (minimum 6 feet distance between 2 persons) and frequent hand-wash/ sanitizing.
