**(COVID-19 CONTROL ROOM)**

**ORDER**

In continuation of this office order issued vide letter No. COVID-19/4724-4744 dated 29.11.2020, COVID-19/4790-4810 dated 15.12.2020 vide which night curfew, restriction on timings of Hotels, restaurants, marriage palaces etc, ceiling on indoor (100 persons) and outdoor (250 persons) social gatherings and restrictions for Covid-Appropriate behaviour were imposed upto 31st Dec, 2020.

As per latest guidelines received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide letter No. 7/56/2020/2H4/5120 dated 29th December, 2020 (copy enclosed), considering the recent downtrend in COVID-19 cases, while restrictions regarding night curfew (10 pm to 5 am) in all cities/ towns and closing down hotels, restaurants, marriage palaces etc. by 9.30 pm in the district shall continue upto 31th December, 2020, both these restrictions shall no more be applicable. w.e.f. 1st January, 2021 onwards.

Ceiling of 100 persons and 250 persons in all the indoor and outdoor social gatherings in the State applicable upto 31th December 2020 also stands further relaxed to 200 persons and 500 persons in all the indoor and outdoor social gatherings respectively w.e.f. 1st January, 2021 onwards.

However, strict implementation of all the extant directive of MHA/State Government including keeping social distance of minimum 6 feet distance (do gaz ki duri), regulating crowds in markets and public transport and imposition of penalties prescribed for violation of Covid- Appropriate behaviour like wearing of face masks and spitting in public etc. must be ensured by all concerned.

These directions are to be strictly implemented by all concerned authorities.
