ORDER

In continuation of this Office Order vide Letter No. COVID-19/4831-4850 dated 30.12.2020 stressing the need for maintaining caution and strict surveillance so as to fully overcome the COVID-19 Pandemic.

The district authorities have been accordingly advised to ensure strict compliance of all the covenants of MHA directives dated 27th January, 2021 and as per latest guidelines received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide Letter No. 7/56/2020/2H4/477 dated 28th January, 2021 (copy enclosed), all activities including cinemas and theatres, swimming pools and exhibition halls are hereby permitted outside Containment Zones subject, however, to SOP of the concerned departments, while ceiling of 250 persons and 500 persons on various indoor and outdoor social/ religious/ sports/ entertainment/educational/cultural/religious gatherings shall continue to be applicable.

The authorities shall, however, continue to ensure strict implementation of all the extant directives of MHA/State Government including keeping social distancing norm of minimum 6 feet distance (*do gaj ki doori*), regulating crowds in markets and public transport and imposition of penalties prescribed for violation of COVID appropriate behaviour like wearing of face masks and spitting in public etc. must be ensured by all concerned.

These directions are to be strictly implemented by all concerned authorities.
