



OFFICE OF DISTRICT MAGISTRATE, AMRITSAR

ORDER

In order to contain the spread of Covid-19 and in order to safeguard public interest at large, in exercise of powers bestowed under the Epidemic Diseases Act, 1897 (COVID-19 Regulations 2021), it is hereby ordered that :-

1. The ceiling of 100 persons (for indoor) and 200 persons (for outdoor) on various indoor and outdoor Social/Religious/Sports/Entertainment/Cultural gatherings shall be strictly enforced. Fine shall be imposed for violation of above ceiling limit on the organisers and the persons found violating social distancing and are without face masks at such gatherings. The organisers of such events will be Covid Monitors for ensuring Covid appropriate behaviour. Any violation of Covid advisory at their organized event will be their responsibility. The organisers of such events shall ensure that any person attending such event should be either tested negative for Covid 72 hours prior to the event or should have been vaccinated and carries its proof. All the SDMs and their Police counterparts will ensure that these directions are strictly followed in their sub divisions by regularly visiting marriage palaces and restaurants etc.

(Action by Department of Police, Health, Revenue and Excise).

2. Fine shall be imposed on violation on the persons roaming at crowded places like chowks etc. without wearing of face masks and such persons will be stopped and tested for Covid-19 on the spot.

(Action by Department of Police and Health).

3. Fine shall be imposed on all the shopkeepers and customers not using face masks. Such persons will also be tested for Covid-19.

(Action by Department of Police and Health).

These directions are to be strictly implemented by all concerned authorities.


