(Covid-19 Control Room)


Keeping in view the larger public interest in the scenario of emerging threat of pandemic Covid-19, In continuation to earlier order No Covid-19/6324-6345 dated 17-04-2021 and keeping in view of latest guidelines received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide no 7/56/2021/2H4/1968 dated 19.04.2021 (Copy enclosed). I, Gurpreet Singh Khaira, IAS, District Magistrate, Amritsar, in exercise of powers conferred upon me under section 144 of CrPC 1973 and National Disaster Management Act, 2005 hereby order:-

- I. All bars, cinema halls/multiplexes, gyms, spas, swimming pools, coaching centres, sports complexes to be closed.
- II. All restaurants (including in Hotels) to be closed and only take-away/home delivery to be allowed.
- III. No gathering of people more than twenty (20) persons to be allowed, including for weddings/cremations. Every gathering of over ten (10) persons to be with prior approval of District Administration, Amritsar except for cremations. The application for the same be sent on email id amritsarcontrolroom@gmail.com on working days.
- IV. Persons who have attended large gathering anywhere (religious/political/social) to be mandatorily home quarantined for five (05) days and tested as per protocol.
- V. Night Curfew timing across District Amritsar shall be from 8:00PM to 5:00AM, including for weddings. However, all the essential activities including operations of industry, as well as 'to and from' movement of passengers travelling via air, trains, buses, etc. shall remain exempted from Curfew restrictions.
- VI. Number of persons in Public Transport (Buses, Taxis, Autos) to be restricted to 50% of capacity.
- VII. All malls, markets, shops, restaurants (including in Hotels) to be closed on Sunday other than for essential services. weekly markets to be closed.
- VIII. Government and Private Offices Health/frontline Works and employees over 45 years of age who have not got at least one (01) Vaccine Dose in the last fifteen (15) days or more should be encouraged to take leave and stay home until then Employees under 45 years of age to be allowed only on the basis of negative RT PCR Test report not more than five (05) days old or else should take leave and stay home.
- IX. Micro-Containment zones in High positivity Areas to be increased and strictly enforced. Special Monitors to be designated for enforcement.
- X. Recruitment Exams (such as Patwari, etc) to be postponed.
- XI. COP Asr, SSP (R) Asr, & All SDM's of Amritsar shall also continue to ensure strict implementation of all the extant directives of HMA/State Government on Covid appropriate behaviour including social distancing norm of minimum 6 feet distance (Do Gaz Ki Doori), regulating crowds in market places and public transport, and imposition of penalties prescribed fro violation of Covid appropriate behaviour like wearing of face masks and spiltting in public places etc.

- XII. This orders shall be applicable with effect from 8.00 PM on 20th April 2021 till 30th April 2021.
- XIII. Any violation of this Order shall be punishable under Section 51 to 60 of the Disaster Management Act, 2005 besides legal action under Section 188 of the Indian Penal Code (IPC), 1860 prescribed for violation of COVID-appropriate behaviour like wearing of face masks and spitting in public places, etc. shall be strictly enforced.

This Order shall be applicable with effect from 8:00PM on 20th April, 2021 till 30th April, 2021.

Any violation of this Order shall be punishable under Sections 51 to 60 of the Disaster Management Act, 2005, beside legal action under Section 188 of the Indian Penal Code (IPC) 1860.
