Keeping in view the larger public interest in the scenario of emerging threat of pandemic of Covid-19 in continuation to earlier order No. Covid-19/7750-7803 dated 02/05/2021 and the latest guidelines received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide no 7/56/2020/2H4/2182 dated 04.05.2021(Copy enclosed). I, Gurpreet Singh Khaira, IAS, District Magistrate, Amritsar in exercise of powers conferred upon me under section 144 of CrPC 1973 and National Disaster Management Act , 2005 order that:-

1. All the following shops/establishments are also allowed to open till 5 pm except during the weekend curfew (from 6 pm on Friday upto 5 am on Monday):-
 - i. Shops selling fertilizers, seeds, insecticides, pesticides, agriculture machinery, agriculture/horticulture implements, etc.
 - ii. Kirana and grocery Shops including PDS shops.
 - iii. Retail and wholesale liquor vends (but ahatas not to open).
 - iv. Shops selling industrial materials, hardware items, tools, motors, pipes etc.
2. The movement of persons on foot/bicycle for the permissible purposes shall be freely allowed. In case of motorized traffic, valid identity cards may be used. In their absence, e-pass must be taken in advance (<https://pass.pais.net.in>) and displayed.

Any violations shall invite criminal proceedings under the relevant provisions of the Disaster Mangement Act 2005 and the Indian Penal Code 1860.


Sub: Clarification regarding Covid-19 restrictions applicable till 15th May 2021.

1. Reference this office letter No.7/56/2020/2H4/2143 dated 2nd May 2021 in the subject matter vide which, inter alia, shops selling Essential items were exempted from the additional restrictions.

2. In this context, it is clarified that all the following shops/ establishments are also allowed to open till 5 pm except during the weekend curfew (from 6 pm on Friday upto 5 am on Monday):-

- (i) Shops selling fertilizers, seeds, insecticides, pesticides, agriculture machinery, agriculture / horticulture implements, etc
- (ii) Kirana and grocery Shops including PDS shops.
- (iii) Retail and wholesale liquor vendors (but ahas not to open).
- (iv) Shops selling industrial materials, hardware items, tools, motors, pipes etc.

3. The movement of persons on foot/bicycle for the permissible purposes shall be freely allowed. In case of motorised traffic, valid identity cards may be used. In their absence, e-pass must be taken in advance (<https://pass.pais.net.in>) and displayed.
