No. DEO(CDL)/LO/LSE-2019: Whereas, the prevailing law and order situation in Chandel District has been reviewed and examined minutely in view of the ensuring Lok Sabha Elections-2019 and the undersigned in my capacity as the District Magistrate of the District fully convinced and satisfied that there are sufficient reasons/grounds for passing an appropriate order thereby directing the licensed holders of arms to deposit their licensed arms at the nearest concerned Police Stations to ensure that no untoward/unwanted incident occur during the conduct of the ensuring Lok Sabha Election, 2019.

2. Whereas, it is considered necessary to withdraw all the licensed arms in the District and kept in the safe custody of such Police Stations having the jurisdiction where the residence of the license is located in view of the ensuring 17th Lok Sabha Election 2019.

3. Now, therefore, I, Krishna Kumar, District Magistrate, Chandel in exercise of the powers conferred under the Arms Act, 1959, do hereby order that all such licenses of the District shall deposit their licensed arms to the concerned Police Stations on before 08.03.2019 for the maintaining law and order and to ensure peaceful conduct of Election.

4. Any individual who desires to appeal against this order may submit his/her written justification for retaining his/her licensed arms to the office of the undersigned during office hours on or before 3.00 p.m. of 06.03.2019.
