ORDERS

Chandel, the 23rd December 2021

No. DC/CDL/R&DM/COVID-19/2021/: Whereas, the Chairperson, State Executive Committee of the State Disaster Management Authority in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 had issued order dated 20/11/2021 listing out the activities that are permitted, Standard Operating Procedures to be followed in respect of opening of educational Institutions, social gatherings, operation of swimming pools and also imposing curfew.

2. Whereas, another order dated 04/12/2021 has also been issued in view of reported spread of variant of Concern being B.1.1529 for implementation of prompt and effective containment measures for Covid-19 as well as the advisory dated 25/11/2021 issued by the Ministry of Health and Family Welfare, Government of India relating to the new variant, hereby extends the validity of the order of the even number dated 20/11/2021 by another one month and shall be in force till 20/01/2022 vide Order No.H-1601/6/2020-HD-HD dated 21/12/2021.

3. Whereas, there is an emergency and circumstances do not permit the serving of notice in due time upon the public, this order is passed ex-parte under **Sub-Section 2 of Section 144 of Cr. P.C. 1973** and is directed to the public in general.

4. Now, therefore, **I, Shri. Mayanglambam Rajkumar, IAS** District Magistrate, Chandel District, Manipur hereby extends the validity of the order of even number **dated 05/10/2021 by another one month** shall be in force **till 20/01/2022**.

5. **Mandatory wearing of face mask at all gatherings shall be strictly enforced. Event Organizer shall issue clear advance instructions to all invitees/ participants to wear face mask and Organizer shall also keep spare face masks available at the venue. Organizer shall assign specific persons to ensure everyone wears face masks. Superintendent of Police, Chandel and Sub- Divisional Officers, Chandel District shall assign duties to Sub-Divisional Police Officers, Sub Deputy Collectors, etc. to inspect various events/gatherings being organized in their jurisdictions and ensure wearing of face mask by all. Penalties to be imposed promptly on violators, including the Event Organizer.**

SCHEDULE

The whole revenue jurisdiction of Chandel District.

Any persons/Organisation/Institution found violating this Order shall be deemed to have committed an offence punishable under Section 188 and other relevant section of the Indian Penal Code.
