OFFICE ORDER

Whereas. Govt. of Odisha in exercise of powers conferred under section 2, 3 & 4 of the Epidemic Disease Act. 1897 has promulgated Odisha COVID-19 Regulations, 2020 for containment of COVID-19.

And Whereas; the National Disaster Management Authority, Govt. of India in exercise of powers conferred under section 6(2)(i) of the Disaster Management Act, 2005 has directed the State Govt. /Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the national executive committee under the said Act to issue necessary guidelines in this regard.

And Whereas; Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide Order No.2800/R&DM Dated 18.05.2020.

And Whereas; 31 positive cases of COVID-19 have been detected in Paralakhemundi, Municipality of Gajapati District. Thus, contact tracing and active surveillance measures are to be undertaken in the mentioned areas for which the area needs to be contained. Hence, I , **Anupam Saha, IAS, Collector & District Magistrate and the Empowered Officer** declare the following areas coming within the boundary as indicated below as under containment (Map enclosed).

Containment zones

Paralakhemundi Municipality with the following Boundaries:

- Indira Nagar (Surya Nagar)- Kerandi G.P of Gosani Block (Inside town area)
- Subash Nagar – Ward No.1
- Nodia Tota Sahi 1& 2- Ward No.3
- Dhoba Sahi 1 & 2 – Ward No.4
- Bhandari Sahi – Ward No.4
- Matia Sahi- Ward No.8
- Girls High School Road - Ward No.10
- Kandra Sahi 1 & 2- Ward No.12

Entry and Exit of the above mentioned streets sealed.

The indicative sketch Map of the areas are enclosed for reference. The following protocols are to be maintained:

- a. All vehicular movement, movement of Public transport and personal movement will be stopped.
- b. All the inhabitants within the containment zone shall strictly remain in home. All the shopping establishments of whatsoever nature shall be closed

immediately. The supply of Essentials and medical requirements will be ensured through various teams formed by the District Administration, Fire and RWSS.

- c. All the Govt. and Private institutions within the boundary of the containment zone is hereby closed forthwith.

This order comes into effect immediately. The containment will continue for 3 days i.e. from 08/07/2020 time 08:00 A.M to 11/07/2020 time 8:00 A.M. and may be altered as situation warrants.
