### ORDER


Considering the rising number of cases of Covid-19 pandemic in the state of Punjab, the Government of Punjab, Department of Home Affairs and Justice, Chandigarh has issued restrictions from 1<sup>st</sup> July till 10<sup>th</sup> July, 2021 vide letter No. 7/56/2020/ 2H4/ 2914 Dated 30.06.2021.

In Compliance to these instructions and in continuation to this office order No. 3005/MC3/MA Dated 15-06-2021 and order No. 3781/MC3/MA Dated 25-06-2021, I, Apneet Riyait, IAS, District Magistrate, Hoshiarpur in exercise of powers conferred upon me under section 144 of CrPC 1973 order that the restrictions already imposed shall remain in force till 10<sup>th</sup> July, 2021 with following additional relaxation:-

- I. Skill Development Centres and Universities shall be allowed to open conditional to the staff and students having taken at least one dose of vaccine.
- II. Bars, Pubs and Ahatas shall be allowed to open at 50% of their capacity; however social distancing protocols must be maintained and waiters/ servers/ other employees should have taken at least one dose of vaccine.

Any violation of these guidelines and lockdown measures shall be punishable under section 51 to 60 of The Disaster Management Act, 2005 besides legal action under section 188 of Indian Penal Code (IPC).
