1. Stipend of Rs. 1,000/- will be paid to the successful students who have 80% or more attendance.
2. Reimbursement of lodging and boarding charges for outstation students.
3. Application fee of Rs. 100/- (General), Rs. 50/- (Women & Physically handicapped), No fee for SC/ST candidates.
4. Facilitation for the STARTUP - in obtaining loans/ licences, registration etc.
5. Conscious efforts will be made to facilitate self employment of the passouts.

1. The application forms shall be accepted only having I-Card/authorization letter from their respective work places.
2. There will be an orientation of the trainees for a period of five days followed by the Skill Testing on the 6th day.
3. The trainees with minimum attendance of 80% will only be permitted to appear in the course end test.

It is, as such requested to kindly publicize the said short term courses, which are all aimed at eradicating unemployment, through your good offices in your area of jurisdiction. If provided a suitable space we can undertake the short term courses in your area of jurisdiction, except Food Production & Bakery, which would help the candidates cut down the cost on account of the transportation, boarding and lodging,
