ORDER

Sub:- Order under section 144 of CrPC in connection with apprehended danger to human safety- regarding due to COVID-19.

Ref:- MHA order No. 40-3/2020-DM-I(A) dated 24/03/2020.

1. Whereas, in view of the situation emerging due to COVID-19 in District Reasi, that there is sufficient ground for proceeding under section 144 of CrPC for immediate prevention or speedy remedy is desirable to prevent danger to human life, health or safety; and
2. Whereas, this office vide order No. DM/Rsi/2019-20/650-65 dated 25-3-2020 had already imposed restrictions under section 144 of CrPC in District Reasi from **mid night on 25/03/2020 till 11:59PM on 14-04-2020.**
3. Whereas, now due to the extension of lockdown w.e.f. 14-4-2020 to 03-5-2020, restrictions under section 144 of CrPC remained imposed in District Reasi to restrict the unlawful assembly of persons during such period.
4. Whereas the Ministry of Home Affairs GOI, vide above reference letter has also issued certain guidelines for effective implementation of ongoing national lockdown COVID-19.

Now, therefore, in suppression of all previous orders, **I, Rajinder Kumar Sharma, KAS, Additional District Magistrate Reasi** vide powers conferred under section 144 of CrPC do hereby order the following restrictions/directions with effect from **14/04/2020 till the ongoing lockdown is over;**

- i. That there shall be complete shutdown of all Anganwari centers, Schools, Colleges, Universities, Malls, Gyms, Shops, Businesses, markets and establishments etc. within the territorial jurisdiction of district Reasi, **except for notified essential services and supply chains required to maintain the essential services,** notified vide department of Food, Civil Supplies and Consumer Affairs' Government order No. 60-FCS&CA of 2020 dated 22-03-2020 issued vide endorsement no. PS/Secy/FCSCA/01/2020 dated 22/03/2020;
- ii. that there shall be complete restrictions on the movement of Inter State/Intra State Buses; Matadors; and other modes of private/public transports, except for authorized SRTC buses plying for essential purposes and private vehicles on exceptional circumstances with prior approval of the District Magistrate Reasi.
- iii. that there shall be complete ban on assembly of people for any reason whatsoever, provided further that there shall not be an assembly of more than three customers/clients in any establishment for seeking essential services. This shall particularly be ensured by the banks, ATMs, Post Offices & Chemist Shops;

- iv. that assemblies for any kind for demonstrations, rallies, processions, protests etc. are completely prohibited;
- v. that gatherings of any kind (social/cultural/political/religious/academic/sports/seminar/ conference etc.) shall be completely prohibited;
- vi. that people are required to stay at home and shall not move out except to meet an emergent situation due to medical exigency or any unforeseen eventuality after seeking valid permit issued by District Magistrate Reasi.
- vii. that all Grocery shops, vegetables & Fruit vendors shall remain closed till further. However Medical/Chemist shops/stores shall remain open. Milk vendors shall be allowed to supply milk via home delivery only after seeking valid permits issued by the District Magistrate Reasi.
- viii. that Government employees of essential services departments or such other departments as required by government shall be permitted to move on production of passes from District Magistrate, Reasi. Policemen and other CAPF on duty shall, however, not be required to obtain passes
5. Since, it is not possible to serve prior notice of this order, it is as such being issued ex-parte. Any violation of this order shall invite punitive action under section 188 of Indian Penal Code and other relevant section of the Act.
6. This order shall be widely circulated for information of all by the Director, Information and Public Relation.
