ORDER

Subject:-Mapping of Containment/Red zone, Buffer zone and management of COVID-19 in District Reasi.

1. Whereas, orders/instructions have been issued from time to time by this office with regard to the subject for checking the further transmission of Corona virus and breaking of chain of its spread.
2. Whereas, one person belonging to Village Mahore, Tehsil Mahore has been tested positive for COVID-19 on 26-4-2020 and the said person may have met with the resident(s) of the village he belongs to and probably the residents of villages located adjoining to the said village, making residents susceptible to COVID-19.
3. Whereas, after testing the above person positive for COVID-19, it is necessary to break/stop the further transmission of disease in the area and has become imperative to take stringent precautionary measures like declaring/mapping the said area as **Containment/Red Zone** and surrounding area as **Buffer Zone**.

Therefore, I, **Indu Kanwal Chib, KAS, District Magistrate, Reasi**, by virtue of powers vested under the provisions of section 144 of the Code of Criminal Procedure (CrPC), 1973, the National Disaster Management Act, 2005 and the Epidemic Diseases Act, 1897, do hereby order that:

a. The area involving:-

- (i) Panchayat Mahore – D : Jamlan.
 - (ii) Panchayat Sarh – Upper – A : Bharni, Musra, Dhaka.
 - (iii) Panchayat Bathoie – A : Soo Narh.
 - (iv) Panchayat Bathoie – C : Mallah.
- shall be the **Containment / Red Zone**.

b. The area involving:-


- (i) Panchayat Sarh-B : Bagga.
 - (ii) Panchayat Bathoie-A : Bathoie.
 - (iii) Panchayat Mahore-A : Acharlla.
 - (iv) Panchayat Bathoie-C : Chitabass
- shall be the **Buffer Zone**.

- c. There shall be no inward or outward movement of any person(s) from Containment /Red Zone and people shall stay at their homes under complete lock down.
- d. There shall be no vehicular movement even on the internal lanes or roads falling within the containment /red zone.
- e. Sector Officers, BMO and TSO shall ensure the uninterrupted supply of essential commodities as per laid procedure.
- f. Any issue/ information relating to containment/ red zone or buffer zone may be got redressed / sought from the control room established for the purpose with helpline numbers **9149861110 & 9797378001**, functioning around the clock in the office of Sub-divisional Magistrate Mahore.
- g. The area under containment / red zone has been divided into five sectors for which nodal officers are deployed with detail given below :
