ORDER

Sub:- Order under Section 144 of CrPC 1973 read with relevant provisions under Epidemic Disease Act,1897 and Disaster Management Act 2005 in view of apprehended danger to human safety.


Ref:- J&K Government order No. 49-JK (DMRRR) of 2020 dated 03-05-2020

Whereas, the State Executive Committee of Department of Disaster Management, Relief Rehabilitation & Reconstruction vide Government order No. 49-JK (DMRRR) of 2020 dated 03-05-2020 has issued guidelines/ instructions, regulating activities within Union Territory of Jammu and Kashmir for effective containment of COVID-19 w.e.f. 4th May 2020 till further order;

Whereas, as per Para No. 3 (IX) of the Annexure to the aforementioned order, "The Movement of Individuals for all non-essential activities between 7:00PM to 7:00AM is non permissible activity requiring District Magistrate to issue specific prohibitory orders in this regard";

Now, therefore, I, Indu Kanwal Chib, KAS, District Magistrate Reasi vide powers conferred upon me under section 144 of CrPC 1973 read with relevant provisions under the Epidemic Disease Act,1897 and Disaster Management Act, 2005 do hereby restrict the movement of individuals for all non-essential Activities between 7:00PM to 7:00AM within the territorial limits of District Reasi.

Since it is not possible to serve prior notice of this order, it is as such being issued ex-parte. Any violation of this order shall invite punitive action under section 188 of Indian Penal Code and other relevant sections of Epidemic Disease Act, 1897 and Disaster Management Act 2005.
