ORDER

Sub:- Mapping of Containment Zone and management of COVID-19 in District Reasi.

Whereas, orders/instructions have been issued from time to time by this office with regard to the subject for checking the further transmission of Corona virus and breaking of chain of its spread.

Whereas, on 16-06-2020, one person belonging to Village Gundali, Tehsil Thakrakote has been tested positive for COVID-19. There is every apprehension that the above person belonging to Ward No. 7 (Gundali) of Panchayat – Bandhar, village Gundali, may have come in contact with the other residents of the adjoining areas.

Whereas, it has become necessary to impose strict restrictions in such areas to break/stop the further transmission of COVID-19 in the area and has become imperative to take stringent precautionary measures like declaring/mapping the said areas as **Containment Zone** and surrounding area as **Buffer Zone**.

Therefore, in view of above I, **Indu Kanwal Chib, KAS, District Magistrate, Reasi**, by virtue of powers vested under the provisions of Section 144 of the Code of Criminal Procedure (CrPC), 1973, Disaster Management Act, 2005 and the Epidemic Diseases Act, 1897, do hereby declare the following areas as Containment Zone and restrict the movement of general public in this area.

Containment Zone

- (i) Ward No. 07 Gundali of Panchayat Bandhar Block -Thakrakote
- (ii) Ward No. 08 Gundali-II of Panchayat Bandhar Block - Thakrakote


Restrictions/Arrangements

1. There shall be only one entry and exit point in the containment zone from the location near Dev Sathan(Gundali).
2. There shall be no inward/outward movement of any person(s) in the containment zone and people shall stay at their homes under complete lock down.
3. **Sh. Chain Singh, Naib Tehsildar Thakrakote (7889373258, 9419165221)** shall be the Magistrate / Nodal Officer for the Containment Zone.
4. **Assistant Director FCS&CA** shall ensure the supply of LPG, Essential Commodities & Milk in the containment zone.
5. The **Drug Inspector Reasi** shall ensure the supply of drugs in the containment zone.
6. The **Block Medical Officer Pouni** shall be responsible for meeting any medical emergency in the red zone.
7. Any issue/ information relating to containment zone or buffer zone may be got redressed / sought through Sh. Mohd. Rafiq, Tehsildar Thakrakote.
8. The area under containment zone has been divided into two sectors (Ward No. 7 Gundali & Ward No. 8 Gundali-II of Panchayat Bandhar, Block Thakrakote) for which nodal officers are deployed with detail given below :

- Daily house to house visits for searching and reporting of clinically suspected cases.
 - Identification of contacts of confirmed/suspected cases.
 - Line listing of family members and those having symptoms of ILI.
 - Isolation of suspects at home till he/she is examined by the Nodal Officer.
 - To perform IEC and IPC activities for COVID-19 in their respective areas.
- Tehsildar Thakrakote (9797602492, 7889878321)** is hereby authorized to make necessary local arrangement(s) as and when the need arises.
 - Any person(s) / group(s) / institution(s) / organization(s) / association(s) / NGO(s) found violating the directions contained herein, shall be booked under provisions of relevant Law/Act/Rule.
