ORDER

Sub: Mapping of Containment Zone and management of COVID-19 in District Reasi.

Whereas, orders/instructions have been issued from time to time by this office with regard to the subject for checking the further transmission of Corona virus and breaking of chain of its spread.

Whereas, on 26-7-2020, one person belonging to W. No. 3 of Panchayat Budhan- A has been tested positive for COVID-19. There is every apprehension that the above person belonging to Ward No. 3 of Panchayat Budhan Tehsil Thuroo and main market Dharmari, may have come in contact with the other residents of the adjoining areas.

Whereas, it has become necessary to impose strict restrictions in such areas to break/stop the further transmission of COVID-19 in the area and has become imperative to take stringent precautionary measures like declaring/mapping the said areas as **Containment Zone**.


Therefore, in view of above I, **Indu Kanwal Chib, KAS, District Magistrate, Reasi**, by virtue of powers vested under the provisions of Section 144 of the Code of Criminal Procedure (CrPC), 1973, Disaster Management Act, 2005 and the Epidemic Diseases Act, 1897, do hereby declare the following areas as Containment Zone and restrict the movement of general public in such areas.

Containment Zone:

- (i) Ward No. 2, (Partially) Panchayat Budhan-A.
- (ii) Ward No. 3, (Partially) Panchayat Budhan-A.
- (iii) Ward No. 7, (Partially) Panchayat Budhan-A.

Restrictions/Arrangements:

1. There shall be only one entry and exit point in the Containment zone. **Station House Officer Mahore** shall ensure strict lockdown and tight perimeter control, except for essential commodities/needs.
2. There shall be no inward/outward movement of any person(s) in the containment zone and people shall stay at their homes under complete lock down.
3. **Sh. Mohd. Iqbal, Naib Tehsildar Budhan (9596665686)** shall be the Magistrate for the Containment Zone.
4. **Sh. Gulzar Ahmed, (9596699185) Master, GMS Karamkatha**, shall be the **Nodal Officer** for the containment zone who shall be assisted by the team of following officials who shall ensure delivery of essential items in the containment zone.

5. **Assistant Director FCS&CA Ramban** shall ensure the supply of LPG, Essential Commodities & Milk in the containment zone.
 6. The **Drug Inspector Reasi** shall ensure the supply of drugs in the containment zone.
 7. The **Block Medical Officer Mahore** shall be responsible for meeting any medical emergency in the containment zone. Further, Block Medical Officer Mahore shall ensure sampling of people in containment zone according to the guidelines issued by SEC vide Govt. Order No. 63-JK (DMRRR) of 2020 dated: 24.6.2020.
 8. Any issue/ information relating to containment zone may be got redressed / sought from the control room established for the purpose with helpline numbers 7006721872 & 9906061053 functioning around the clock in the Office of Sub-Divisional Magistrate, Dharmari.
 9. The area under containment zone shall be monitored by below mentioned team.

 - d. Isolation of suspects at home till he/she is examined by the Nodal Officer.
 - e. To perform IEC and IPC activities for COVID-19 in their respective areas.
