ORDER

Sub:- Mapping of Containment Zone and management of COVID-19 in District Reasi

Whereas, orders/instructions have been issued from time to time by this office with regard to the subject for checking the further transmission of Corona virus and breaking of chain of its spread.

Whereas, on 22-7-2020, two persons belonging to Ward No. 7 of Municipal Committee Reasi have been tested positive for COVID-19. There is every apprehension that the above persons belonging to Ward No. 7 of Municipal Committee Reasi, may have come in contact with the other residents of the adjoining areas/Wards.

Whereas, it has become necessary to impose strict restrictions in such areas to break/stop the further transmission of COVID-19 in the area and has become imperative to take stringent precautionary measures like declaring/mapping the said areas as **Containment Zone**.

Therefore, in view of above I, **Indu Kanwal Chib, KAS, District Magistrate, Reasi**, by virtue of powers vested under the provisions of Section 144 of the Code of Criminal Procedure (CrPC), 1973, Disaster Management Act, 2005 and the Epidemic Diseases Act, 1897, do hereby declare the following areas as Containment Zone and restrict the movement of general public in such areas.

Containment Zone:

- (i) **Ward No. 5 (Partially) of Municipal Committee, Reasi.**
- (ii) **Ward No. 7 (Partially) of Municipal Committee, Reasi.**
- (iii) **Ward No. 8 (Partially) of Municipal Committee, Reasi**

Restrictions/Arrangements:

1. There shall be only one entry and exit point in the Containment zone from the lane near Zanana Park, Reasi. **Station House Officer Reasi** shall ensure strict lockdown and tight perimeter control, except for supply of essential commodities/needs.
2. There shall be no inward/outward movement of any person(s) in the containment zone and people shall stay at their homes under complete lock down. All shops in the containment zone shall remain closed.
3. **Sh. Baldev Raj Naib Tehsildar Reasi (7006062629)** shall be the Magistrate / Nodal Officer for the Containment Zone. He shall be assisted by

the team of following officials who shall ensure delivery of essential items in the containment zone.

- a. Wajid Niaz, Patwari, Patwar halqa, Reasi (7006313856)
- b. Shakeel Ahmed, Election Assistant, Reasi (9906989568)
- c. Muzaffar Iqbal Wani, Tearcher, HS Chinkah (9622264974)
- d. Tariq Aizaz, Teacher, MS Gulabgargh,(9622038779)

4. **Tehsil Supply Officer (TSO) Reasi** shall ensure the supply of LPG, Essential Commodities & Milk in the containment zone.
5. The **Drug Inspector Reasi** shall ensure the supply of drugs in the containment zone.
6. The **Block Medical Officer Reasi** shall be responsible for meeting any medical emergency in the containment zone. Further, Block Medical Officer Reasi shall ensure sampling of people in containment zone according to the guidelines issued by SEC vide Govt. Order No. 63-JK (DMRRR) of 2020 dated: 24.6.2020.
7. The Executive officer, Municipal Committee, Reasi shall ensure the proper fumigation of the area within containment zone.
8. Any issue/ information relating to containment zone may be got redressed / sought from the control room established for the purpose with helpline numbers 9419839552 & 9419839553 functioning around the clock in the Office of District Magistrate Reasi.
9. The area under containment zone shall be monitored by below mentioned team.

 - c. Line listing of family members and those having symptoms of ILI.
 - d. Isolation of suspects at home till he/she is examined by the Nodal Officer.
 - e. To perform IEC and IPC activities for COVID-19 in their respective areas.
 - f. To prepare list of households located within the containment zone.
10. Tehsildar Reasi (9419164862) is hereby authorized to make necessary local arrangement(s) as and when the need arises.
 11. Any person(s) / group(s) / institution(s) / organization(s) / association(s) / NGO(s) found violating the directions contained herein, shall be booked under relevant provisions of Law.
