ORDER

Sub:- Mapping of Containment zone, Buffer zone and management of COVID-19 in District Reasi.

Whereas, orders/instructions have been issued from time to time by this office with regard to the subject for checking the further transmission of Corona virus and breaking of chain of its spread; and

Whereas, during the sampling of close contacts of the COVID positive case in Ward No. 02 of Municipal Committee, Katra, one more reported positive on 23.7.2020.

Whereas, there is every apprehension that the above person(s) may have come in contact with the residents of the adjoining areas; and

Whereas, it has become necessary to impose strict restrictions to stem the further transmission of COVID-19 in the area and to take stringent precautionary measures like declaring/ mapping the said area as **Containment zone** and surrounding area as **Buffer Zone**.

Therefore, in view of above I, **Indu Kanwal Chib, KAS, District Magistrate, Reasi**, by virtue of powers vested under the provisions of Section 144 of the Code of Criminal Procedure (CrPC), 1973, Disaster Management Act, 2005 and the Epidemic Diseases Act, 1897, do hereby declare the following area as Containment Zone and Buffer Zone and restrict the movement of general public in such area.

Containment Zone

(i) 11 households of Ward No. 02 (partially) Municipal Committee, Katra (as per the enclosed map).

Buffer Zone

Entire W. No. 02 of Municipal Committee, Katra

Restrictions/Arrangements

1. There shall be only one entry and exit point in the containment zone of ward no. 02 from Palak Resort lane.
2. There shall be no inward/outward movement of any person(s) in the containment zone and people shall stay at their homes under complete lock down.

3. There shall be no vehicular movement even on the internal lanes or roads falling within the containment zone.
4. **Sh. Kamal Kishore, Naib Tehsildar, Katra/Pintail (9419175146)** shall be the Magistrate for the Containment Zone.
5. **Sh. Bhupinder Heera (9906163387), Lecturer, Higher Secondary School, Panthal (Katra)**, shall be the **Nodal Officer** for administrative arrangements for Containment Zone. Sh. Kuldeep Sharma (9596999972), Lab Bearer, Govt. Higher Secondary School, Katra shall assist the Nodal Officer.
6. **Tehsil Supply Officer, Katra, FCS&CA** shall ensure the supply of LPG, Essential Commodities & Milk in the containment zone.
7. The **Drug Inspector Reasi** shall ensure the supply of drugs in the Containment zone.
8. The **Block Medical Officer, Katra** shall be responsible for meeting any medical emergency in the Containment zone.
9. Any issue / information relating to containment zone or buffer zone may be got redressed / sought from the control room established for the purpose with helpline numbers 9419839552 & 9419839553 functioning around the clock in the Office of District Magistrate Reasi.
10. The surveillance team consisting of following medical staff under the supervision of Dr. Shami (M.D Medicine) has been deployed for W. No. 02.

The surveillance team deployed for Containment zone shall perform following duties:-

- a. Daily house to house visits for searching and reporting of clinically suspected cases.
- b. Identification of contacts of confirmed/suspected cases.
- c. Line listing of family members and those having symptoms of ILI.
- d. Isolation of suspects at home till he/she is examined by the Nodal Officer.
- e. To perform IEC and IPC activities for COVID-19 in their respective area.
