**Sub:- Tender Notice for hiring of 08 vehicles under RBSK Scheme & 01 Vehicle for DY.
CMO Office for the F.Y 2020-21 (from 01-12-2020 to 30-11-2021).**

As approved by the Chairman District Health Society (District Development Commissioner Reasi) sealed tenders are invited from permanent resident of J&K State for empanelment of Light Motor Vehicle Operators in District Reasi for the Mobile teams under Rashtriya Bal Swasthya Karaykram & for Dy. CMO Office for screening of children by the RBSK Teams & under Immunization Head of National Health Mission. The interested parties are requested to submit the sealed tenders affixed with Rs. 5.00 revenue stamp (clearly marked on the envelop bid for hiring of vehicles). The sealed tenders must reach in the office of Vice Chairman District Health society Reasi (Chief Medical Officer Reasi) on or before 25th of Oct 2020 and will be opened in presence of tenderers on Wednesday, 28-10-2020 at 11 am in the office chamber of District Development commissioner Reasi (The opening of Tenders will purely depend upon the consent & availability of Worthy District Development Commissioner Reasi). The acceptance and finalization of tenders will be subject to the following terms and conditions.

TERMS AND CONDITIONS


1. The minimum numbers of vehicles required is 09 (Nine). The List of Description of Nine numbers of vehicle with Make/Model No are also require in the sealed Tenders.
2. The commercial vehicle required should be of make Scorpio, Innova, Tata Sumo, Tavera, Xylo, Bolero and in good motor able condition not prior to 2014 model with complete renewal document required not prior to 2014 model with complete document required under rules. The Vehicles will be stayed during the night at their respective Blocks Head quarter.
3. These rates shall be operative up to 30-11-2021. The Payment shall be paid to the selected tenderer on the per KM Basis/Monthly basis of Log Book or as decided by the Selection committee of RBSK hiring Vehicles.
4. The Maximum Amount of Sealing Tender is Upto 35000/- (Thirty Five thousand only) Per Vehicle.
5. The parties my quote the rates of hiring on Daily/weekly/monthly and also the rates chargeable per km basis both in figure as well as in words including repairs fuel and drivers etc. & The Drivers will have to keep & bring the heavy driving licenses.
6. The successful tenderers shall execute an agreement with District Health Society Reasi under the prevailing norms. In case the successful tender breaches the agreement any time he shall be liable to charge penalty to the extent of security.



7. The District Health Society is empowered to disengage any vehicles any time if the vehicle becomes defective or on the basis of any other unavoidable circumstances. The tenderers will have to get repair the vehicles repaired or replaced within 24 hours if any vehicles becomes defective.
8. The tenderers should enclose CDR/FDR of Rs 50,000/- (Rupees fifty Thousand only) pledged to Chief Medical Officer Reasi as security which shall be released to successful tenderers after completion of contract. The security will be refunded to unsuccessful tenderers after the tender process is completed.
9. The tenderer should be registered under Motor Vehicle Act having GST Number, So that service Tax, Income Tax, labor cess is deducted and credited to the proper accounts. The tenderers who have also registered in Gem portal should also enclose the copy of GEM Registration during the submission of sealed tenders.
10. The Committee reserves the right to accept or reject any tender without assigning any reason thereof.
11. The Tenderers must bring GST Number, registration under Motor Vehicles Act and PRC at the time of opening of tenders.
12. The tender notice is also available on official web-site of District Reasi i.e. www.reasi.gov.in.
13. Those Tenderers who have already submitted the CDR are requested not to submit again to this office.
14. The approved rate shall remain valid for a period of Twelve Months from the date of issuance of Contract & will be further extendable for a period of 90 days or till such time the new rate contract comes into force, whichever is earlier.
