ORDER


Whereas, Joint Secretary, Examinations, JD, the Jammu & Kashmir, State Board of School Education, Jammu vide his letter No:-JSE/B/JD/2020 dated 28-10-2020 and Notification No. (Exam-III)DS/B/JD/Reg/WZ/2020 dated:- 05-11-2020 has intimated that the Secondary School Examination (Class -10th), Annual Session Regular 2020, Winter Zone, Jammu Division has commenced w.e.f. 09-11-2020 at 11:00 AM and the Higher Secondary Examination Part-II (Class -12th) Annual Session Regular 2020, Winter Zone, Jammu Division is commencing w.e.f. 12-11-2020 at 11:00 A.M.

Whereas, the Examination Superintendents/Head of the Institutions shall ensure complete sanitization of Desks /Examination Halls/ Rooms one day before the commencement of these Examinations and strictly follow the SOPs issued by the UT Administration /Health Department from time to time with regard to the COVID-19 Pandemic disease. Besides, the candidates & supervisory staff deployed in the examination centres shall use face masks/ hand sanitizers/ maintain social distancing and proper medical examination/ scanning of appearing candidates by Thermal Scanners, which shall be provided by Health Department. At each examination centre, proper hand washing liquid soap facility and free distribution of face masks shall be ensured by the concerned Head of the Institution.

Whereas, in order to maintain the Law & Order and for smooth conduct of the examination in District Reasi, it is necessary to impose the restrictions upon the general public not to enter and gather within radius of 200 meters from the venue of the examination centres.

In view of the above, I, **Rajinder Kumar Sharma, KAS, Additional District Magistrate, Reasi** by virtue of powers vested in me under section 144 Cr.PC, do hereby, impose the above noted restrictions around the Examination Centres in District Reasi, as per list enclosed, for the smooth conduct of the above said examination with immediate effect till the completion of the said examinations.
