**ORDER**

**Sub:-Ban on parking/standing of heavy vehicles viz loaded /unloaded Tippers, Trucks, Dampers etc. on Kanthan bridge, Tehsil Arnas, District Reasi.**

Whereas, it has been brought to the notice of this office by O.C. GREF, RCC 110 that heavy loaded / unloaded vehicles viz Tipper, Trucks, Dampers are frequently parked/ stopped on the Kanthan bridge situated at Kanthan over the River Chanab, Tehsil Arnas, District Reasi;

Whereas, the Kanthan bridge is very old structure and standing/ parking of heavy loaded / unloaded vehicles like Tippers /Dampers/ Trucks etc. on the bridge may cause damage to the bridge structure, which may ultimately cause a mishap thereby posing grave danger to the life of the general public in future. The precautionary measures in this regard are necessary to be taken;

Whereas, the minor mineral Block No. 27 at Kanthan has been leased out to the lessee for regulated mining as a result a large number of heavy loaded / unloaded Dampers /Tippers /Trucks are often seen stranded /parked at the bridge and also along both sides of approach roads to the bridge thereby posing grave danger to the old bridge besides causing traffic jams thereby creating inconvenience to the general public;

Whereas, a complete ban/restrictions on standing/ parking of heavy loaded /unloaded vehicles over the Kanthan bridge is necessary to be imposed to ensure the safety of the said structure and life of the people.


Therefore, in view of the above, I, **Rajinder Kumar Sharma, KAS, Addl. District Magistrate, Reasi**, by virtue of the powers vested in me under section 144 Cr.PC do hereby impose ban/restrictions on the standing/ parking of heavy vehicles loaded /unloaded like Tippers, Trucks, Dampers etc. over the Kanthan Bridge for its protection.

Furthermore, the SDPO, Arnas & SHO, Arnas shall ensure strict implementation of this order and shall ensure that there is no traffic jam at Kanthan due to these heavy Trucks / Dampers.

This order shall come into force with immediate effect.
