SUB:- IMPLEMENTATION OF 100% ELECTRONIC TOLL COLLECTION THROUGH FASTAG AT TOLL PLAZAS- REGARDING.


Madam,

Please refer Ministry of Road Transport and Highways, Govt of India letter No. H-25016/02/2020-Toll Dated: 13.02.2021 & Press Note Dated 14.02.2021 regarding "Promotion of Digital Payment through RFID based FASTag". As per the orders, **all lanes of NH fee plazas has been declared as "FASTag lanes of Fee Plaza" with effect from midnight of 15th/16th February, 2021.** In order to promote the payment through digital mode and to provide a seamless passage to the fee plazas, it has been decided that all the lanes shall be declared as 'FASTag lane of fee plaza' and user of the vehicle not fitted with FASTag entering into fee plazas shall pay a fee equivalent to two times of the fee applicable to that category of the vehicle and they have to install FASTag compulsory on the spot.

Payment of user fee through FASTag will lead to non-stop movement across the Toll plazas in near future. NHA is making every possible effort for hassle-free movement of VVIP, Defence Personnel, Ambulance and other exempted vehicles and avoiding the traffic Jams.

Keeping in view of above, it is requested to direct all concerned for necessary cooperation in implementing Govt of India decision "Toll payments via FASTag only w.e.f. 15th/16th February, 2021 throughout India.
