Whereas, J&K Services Selection Board, Jammu has intimated vide his letter No.SSB/Sel/Secy/ 2021/1069-90 dated 03-02-2021 that J&K Services Selection Board (JKSSB) with the support of District Administration is conducting three days Objective Type Written Examination for District Cadre posts of Class - IV in respect of District Reasi on 27th, 28th February & 1st March, 2021 from 12:00 Noon to 2:00 PM in the following centers of District Reasi and also requested to make all necessary arrangements including imposition of u/s 144 Cr.P.C. to maintain Law & Order problem for smooth conduct of the examinations.

Whereas, the Centre Superintendent (CS)/Head of the institutions shall ensure complete sanitization of Desks/Examination halls/rooms every day before the commencement of these examinations and strictly follow the SOPs issued by the UT Administration/Health Department from time to time with regard to the COVID-19 Pandemic disease. Besides, the appearing candidates and supervisory staff deployed in the examination centres shall use face masks/hand sanitizers/maintain social distancing and proper medical examination/scanning of appearing candidates by Thermal scanners which shall be provided by Health Department. At each examination centre, proper hand washing liquid soap facility and free distribution of face masks shall be ensured by the concerned Head of the institution.

Whereas, in order to maintain the Law & Order and for smooth conduct of the Objective Type Written Examinations on the aforementioned dates for District Cadre Class – IV posts in District Reasi, it is necessary to impose the restriction upon the general public not to enter and gather with in radius of 200 meters from the venue of the examination centres.

In view of the above, I, **Rajinder Kumar Sharma, KAS, Additional District Magistrate Reasi**, by virtue of powers vested in me under section 144 Cr.P.C. do hereby, impose the above noted restriction around the examination centers in District Reasi, for the smooth conduct of the above said examination with immediate effect till the completion of the said examinations.
