Whereas, the festival of "Maha Shivratri" is falling this year on 11-03-2021 and the celebration of said festival will commence **w.e.f 10-03-2021 to 12-03-2021** at Shivkhori Ransoo;

Whereas, a large number of devotees/pilgrims are expected to visit from all over the country on the eve of "Maha Shivratri";

Whereas, it has come into notice of undersigned that some mischievous elements may disturb the law and order situation of the area by consuming liquor, which can create stampede/disturbance etc. during the said period;

Whereas, it is learnt that some vendors in the garb of Sahardai, sell intoxicating Bhang/Marijuana during the festival to the devotees which may cause disturbance in maintaining law & order and peaceful conduct of Mela;


Whereas, in order to avoid any such disturbance, it is imperative to impose restrictions on sale/possession/consumption of liquor & Sahardai/Bhang/Marijuana in Tehsil Pouni w.e.f. 10-03-2021 to 12-03-2021 and Tehsil Reasi/Arnas of District Reasi on 11-03-2021.

Therefore, in view of the above, I, Rajinder Kumar Sharma, KAS, Addl. District Magistrate Reasi in exercise of powers vested in me under section 144 CrPC do, hereby order that the sale/possession/consumption of liquor & Sahardai/Bhang/ Marijuana within the jurisdiction of Tehsil Pouni shall remain prohibited w.e.f 10-03-2021 to 12-03-2021 and Tehsil Reasi/Arnas of District Reasi on 11-03-2021.
