ORDER

Sub:- Restrictions to contain the fresh wave of COVID-19 in District Reasi.

Whereas, the Department of Disaster Management, Relief, Rehabilitation & Reconstruction (DMRRR) vide order No. 22-JK(DMRRR) of 2021 dated 20-4-2021 has imposed restrictions to contain the spread of fresh wave of COVID-19 in Union Territory of J&K;

Whereas, a meeting with the members of Market Associations Reasi headed by President MC Reasi held on 20-4-2021 and pattern to implement the COVID restrictions are discussed in the office of undersigned;

So, in compliance with the above said order passed by the State Executive Committee, **I, Ajay Kumar Sharma (KAS), District Magistrate Reasi** by virtue of the powers vested u/s 144 of CrPC, 1973, The National Disaster Management Act 2005 and the Epidemic Diseases Act 1897 do hereby impose the following restrictions within the territorial jurisdiction of District Reasi.

1. There shall be **Corona Curfew at night from 10:00PM to 6:00AM** within the Municipal Limits. However, movement of Vaishno Devi Pilgrims through limits of MC Katra shall be allowed.
2. Public Transport (Matadors/Mini Buses/Buses etc.) shall be permitted to ply only at 50% of its authorized seating capacity.
3. Shops located within the MC limits of Reasi & Katra town shall be allowed to **open on every Monday, Wednesday & Friday**. However, shops dealing in dairy products shall be allowed to open upto 11:00AM on daily basis and Medical Shops shall be allowed to open throughout the week. For facilitation of Shri Mata Vaishno Devi Pilgrims, all eating points/Dhabas/Restaurants/Hotels shall remain open on all days.

This order shall come into force w.e.f. 21-4-2021 till further orders.
