ORDER

Whereas, the work of Railway Projects, Katra Dharam Section, Udhampur - Srinagar-Baramulla Rail Link Projects (USBRLP) is being executed by the Northern /KONKAN Railways within the jurisdiction of District Reasi;

Whereas, it has been brought to the notice of undersigned by Railway Companies letter No. AFC/2629/Site/101/PM/KRCL/2664 dated 19-09-2020 and No. KR/PD/J&K/Br/REASI/Local-Corres/2020/09 dated 19-09-2020 that some miscreants/ mischievous elements may disturb the ongoing works of the Railways in the different locations of this District by misleading the workers/ labourers unnecessarily and creates interruption in the civil works of Railways Projects;

Whereas, the Hon'ble Prime Minister of India is individually monitoring these ongoing works of Railway Projects in different site of J&K. These projects are sanctioned by the GOI particularly in accordance with the time bound manner. There should be no such any unlawful interference of outsiders is to be required for smooth running of the ongoing works of Railway Projects, which is being executed by the Northern / KONKAN Railways /IRCON through different Private Construction Companies viz AFCON Infrastructures, HCC Ltd. Anji, HCC Limited, Dugga, VCCL MAX Infra Limited, Patel Engineering, ABCIIL & Chenab Bridge Project Undertaking(AFCONS) with regard to making the Railway Track, Tunnels, Bridges & Approach roads;

Whereas, owing to which the Railway works suffers badly and also creates Law & Order problems;

Whereas, the general public/ representative of Unions and workers/ labourers having any objection with regard to the salary norms/ land coming under the Railways Projects, etc. may take up the matter with concerned Central Labour Commissioner, Jammu;

Whereas, it is necessary to impose restrictions/ prohibition on unlawful assembly of any such miscreant/ mischievous elements at the Railways Work Sites;

Whereas, the restrictions have already been imposed by this office vide Order No.DM/Rsi/20-21/4036-52 dated 29-03-2021;

In view of the above, therefore, I, **Rajinder Kumar Sharma, KAS, Addl. District Magistrate, Reasi** by virtue of powers vested in me under section 144 Cr.PC. do hereby impose restrictions /prohibition on assembly of four or more people, and any kinds of protest meetings/ rally without permission from magistrate concerned /blockage of road/work sites including batching plants, labour camps, office camps and main office complex/ forceful stoppage of works and any types of interference made by the Public or outsiders at worksites/roads & in radius of 1 Km which creates the interruption in the ongoing works of Northern Railways /KONKAN Railways at the Railways Work Sites of District, Reasi.

This order shall come into the force with immediate effect and shall remain in force for two months only from the date of issue.
