Sub:- Imposition of ban on storage, sale, possession, use and transport of drones/ flying objects/flying toys.

Order No.: 30-DC (Rsi) of 2021

Whereas, in the recent past some incidents have occurred in some parts of the UT of Jammu & Kashmir wherein Anti-national elements have used drones and similar flying objects to cause damage, injury and risk to the human lives, besides posing threat to the vital installations; and

Whereas, the domestic use of small drone cameras/flying objects has increased manifold in the society generally in the marriage functions and for capturing aerial images & videos and in social and cultural gatherings. The youth and kids are more attracted towards these flying objects/drone like toys and electronic flying gadgets which may be used by the Anti-national elements;

Whereas, in order to secure our aerial space near vital installations and highly populated areas, it has become imperative to impose reasonable restrictions on storage, sale, possession, use, and transport of drones and similar flying objects/toys to reduce the apprehension of any risk to life and property;

In view of above, **I, Charandeep Singh JKAS, District Magistrate, Reasi in exercise of powers conferred upon me under Section 144 CrPC do hereby impose restrictions/ban on sale, storage, possession, use and transport of drones/flying objects/flying toys in the jurisdiction of District Reasi.** Those already having in their possession drone cameras/flying objects/toys or similar objects are directed to immediately deposit the same in the local Police Station against proper receipt.

Various Government Departments which are using drones for mapping, surveys, surveillance in construction works, agricultural, environmental

conservation and disaster mitigation sectors and for creating pictures/movies shall inform the local Police Station Incharge and the Executive Magistrate concerned.

Since, it is not possible to serve prior notice of this order, it is, as such being issued ex-parte. Any violation of this order shall attract punitive action as warranted under relevant law.

Senior Superintendent of Police, Reasi shall implement this order in letter & spirit.
