In continuation to order No. 31-DC(Rsi) of 2021 dated 09-07-2021 issued under endorsement No. **DM/Rsi/21-22/JC/1955-73 Dated: 09-07-2021**, it is hereby ordered that:

- (1)All shops falling within the jurisdiction of **Municipal limits of Katra** shall be allowed to open on 17-07-2021 to 18-07-2021 from **09:00 AM to 09:00 PM.**
- (2)All shops falling within the jurisdiction of **village Ransoo** shall be allowed to open on 17-07-2021 to 18-07-2021 from **07:00 AM to 07:00 PM.**

**The opening of the establishments as detailed above shall remain subject to maintaining of Covid Appropriate Behavior. The employees/visitors in the commercial establishment/Bazaars shall have a negative test report (RAT) of atleast 48 hours prior. Any deviation in maintaining Covid Appropriate Behavior or not having negative test report may lead to restrictions/closure of the establishments.**

Any violation of this order shall invite strict punitive action under section 188 of Indian Penal Code and other relevant sections of Epidemic Diseases Act, 1897 and Disaster Management Act 2005.
