**Subject:- Identification of Isolation facilities for Covid Positives in view of surge of Covid Cases.**

**Order No.:-08-DC (Rsi) of 2022**

**Dated:-12-01-2022**

Whereas, in view of emerging situation due to COVID-19, after review of overall situation pertaining to spread of COVID-19 in District Reasi particularly focusing total weekly new cases, total positivity rate and extent of compliance to COVID Appropriate Behavior, it has been observed that there is a sudden spike in Covid positive cases in District Reasi; and

Whereas, in view of the present scenario and guidelines/protocols issued by the Ministry of Health and Family Welfare, GoI and Department of Health and Medical Education, Government of UT of J&K and surge in cases of Covid-19, it has been found expedient to identify the suitable isolation facilities in various establishments/institutions so that the Institutional Health Facilities/Covid Hospitals are not unnecessarily burdened;

In view of above, it is enjoined upon all Colleges/Universities/Belt Forces/NHPC/Hotels/Railway Construction Companies etc. having lodging and hostel facilities functioning/working within the Territorial jurisdiction of District Reasi to create in-house isolation facilities within their campus/formations; subject to fulfillment of SOPs. The details of facilities so identified alongwith capacity and name of contact person shall be communicated to the concerned Block Medical Officer/Chief Medical Officer, Reasi within two days positively as per **Annexure "A"**.
