ORDER

Whereas in view of the present public health emergency situation, quarantine facilities are to be established in various parts of the District to protect and safeguard the lives of general public.

In this regard vide various orders passed under Section 33,34 & 65 of Disaster Management Act, 2005, certain private Institutions/Premises have been requisitioned for setting of quarantine facilities.

Accordingly now, consolidated list of various quarantine facilities established in the District alongwith bed capacity is hereby published as under for information of all concerned alongwith name of the officer Incharge for such facility.

Whereas vide order No DCP/PA/20/5525-68 dated 20.03.2020 of the office of District Magistrate certain team of officials/employees of various line departments providing assistance to the above mentioned quarantine facilities have been constituted.

It is hereby ordered that such constituted teams shall work under the overall supervision of the officer in-charge as mentioned in Column No. 4 above Moreover, the following officers of the District are entrusted with the responsibilities as mentioned below:-

- 1 .Executive Engineer PHE Division Pulwama/Awantipora shall ensure portable drinking water facilities available at all quarantine facility centers.
- 2 Executive Engineer KPCDL(O&M) Division Pulwama/Awantipora shall ensure un-erratic power supply with alternate back up to all the quarantine facilities.
- 3 Chief Medical Officer Pulwama will designate Medical Officer/Medical team for each of the quarantine facility.
- 4 Assistant Commissioner Development Pulwama/Executive Officer Municipal Committee Pulwama / Pampore / Khrew / Tral /Awantipora will make necessary arrangements for quarantine centre and premises.
- 5 Executive Engineer R&B shall ensure that Civil infrastructure of these facilities is upto date and ensure repairs and renovations wherever necessary. He shall be responsible for

coordinating with concerned executive agencies for such Government Premises of any required works.

- 6 Assistant Director Food Civil Supplies Pulwama and Designated Officers of Food Safety District Pulwama will make arrangements for providing food and other eatables for such quarantine facilities.
- 7 ADC Pulwama/Tral/Awantipora shall be the overall incharge of all quarantine facilities set up in their respective jurisdictions

Any violation of this order shall invite penal action under Section 188 IPC and Section 51 of Disaster Management Act, 2005.
