ORDER

Whereas vide this office Order No. DCP/PA/20/13030-51 Dated:-30-07-2020 restrictions on the movement of people in the entire district Pulwama during the night hours from 10 P.M. to 5:00 A.M. on all days, have been already imposed which were ordered to remain in force initially with effect from 4th May 2020 till 31st July, 2020 and lastly extended upto 6th of August, 2020 vide this office Order No. DCP/PA/20/13030-51 Dated:- 30-07-2020;

Whereas the Government of UT of J&K has issued Order No. 74-JK (DMRRR) of 2020 dated: 04-08-2020 on the subject of Unlock-3 whereby inter-alia, the movement of individuals for all non-essential activities between 10 P.M. to 5 A.M. has been ordered to be prohibited as provided under Para 3 (vii) of the Guidelines annexed to the said Order;


Now therefore, in these circumstances in order to break the transmission chain of Corona virus infection and in the interest of safety and well-being of general public, I Dr. Raghav Langer, IAS District Magistrate Pulwama in exercise of powers vested in me under Section 144 of Cr.PC, Section 34 of Disaster Management Act, 2005 & Section 2 of The Epidemic Diseases Act, 1897, do hereby further order that the restrictions/night curfew imposed vide this Office Order No. DCP/PA/20/13030-51 Dated:- 30-07-2020 are extended till further orders and night curfew shall remain in force on all days between 10 P.M. to 5 A.M. All other stipulations shall remain the same as mentioned in the above referred orders.



Any violation of this order shall attract punitive action under Section 188 of Indian Penal Code read with Section 51 to 56 of Disaster Management Act, 2005.

Enforcement Agencies are directed to take strict action against anyone found violating these orders.
