In reference to the Memo No. 152(31)/MDM/MSD dt. 28/05/2021 of The Addl. District Magistrate(G) Murshidabad, sealed applications are invited for engagement of Carrying-cum Distribution agent of Cooked Mid-day Meal programme in the jurisdiction **of Kandi Municipality in Murshidabad District**, from the enlisted Distributors / Carrying Contractors of Food & Supply Department, Govt. of West Bengal and advised to submit the application in the manner as prescribed below:

- i) The applicant should be the enlisted distributor / carrying contractor of Food & Supply Dept. of West Bengal in Murshidabad district only.
- ii) The applicants shall submit their application in plain paper (explicitly mentioning their tendered rates which shall be within the purview of Order of the Principal Secretary to the Govt. of West Bengal School education Dept., commounicated vide memo no. 259-Es/PLNG/o/MDM-21/2010(pt.-I) dt, 14<sup>th</sup> July 2020of PD, CMDMP read with memo no. 303/1(18)-FS/Sectt/Food/4P-13/2009(Pt-IV) dated 22.01.2019(Annexure-A), clearly mentioning rate for each slab of distance & with NO blank or nil rate for any particular slab)
- iii) The Applicants necessarily should have license issued by the F&S Deptt., Govt. Of West Bengal (to remain valid upto December, 2020 & application for renewal for the year 2021).
- iv) The Applicants should have Trade License, GST Registration Certificate, Godown related documents, last filed ITR, copy of PAN card, copy of EPIC.
- v) The applicants shall be bound to lift food-grains/MDM articles from the assigned lifting point anywhere within the state of West Bengal and deliver to the school points as per direction of the competent authority.
- vi) The applicants shall be solely responsible for maintaining hygiene and proper fumigation in their storing points. Assuring proper quantity and quality of food-grains, as lifted, upto school point shall also be the prerogative of the respective Carrying- cum- Distribution agent.
- vii) The Carrying-cum-Distribution agent shall be obliged to deliver MDM food-grains / articles to the school points for any number of times in a month or a quarter, as and when required upon instruction of the competent authority.
- viii) The government shall not bear any Toll Tax or any other related expenditure for procuring and delivering of MDM food-grains / articles up to the school points.
- ix) The Competent authority shall furnish performance report in respect of the Carrying-cum-Distribution agent upon which their continuity shall be evaluated.
- x) Each financial year, on the basis of report of F&S Dept.; if there is any change (addition or alteration) in the list of Distributors/Carrying Contractors of Food and Supply, fresh tender shall / may be invited.

- xi) The storing points, mode of transportation and register/accounts of MDM food-grains /articles at the Carrying-cum-Distribution agent's end shall be liable to be inspected or evaluated at any time with or without prior intimation.
- xii) The contract / engagement are liable to be cancelled at any point of time, without assigning any reason whatsoever.
- xiii) Applicants must be submitted a separate "Affidavit" (Annexure-B) ( On a non Judicial stamp paper worth Rs. 10) categorically mentioning that he/she understands and agrees to abide the above mentioned clauses without aberration .
- xiv) All documents of the applicant should be self attested.

Applications have to be submitted to the office of the undersigned in plain white paper along with the above mentioned documents in support of their claim through by hand.

ORDER

In view of hike in the price of petroleum products and also hike in operational costs for transportation of food grains under Targeted Public Distribution System, the proposal for revision of transport rebate allowed to Distributors/Wholesalers was under active consideration of the Government since some time past.

In supersession of G.O. No. 3605-FS, dated, 17. 11. 2017 and G.O. No. 2167-F3 dated 08.07.2015, the Governor is pleased to allow Transport Rebate to the Distributors/Wholesalers at the following revised rates with effect from 1<sup>st</sup> February, 2019.

No. 1-4/2018-DESK(MDM) dt: 14.03.2019 revising Transportation Assistance under Mid-day Meal Scheme subject to a maximum amount of Rs. 150/- (Rupees one hundred and fifty) only per qtl. with insistence on strict adherence to the prevalent norms of Transportation Assistance under Public Distribution System (PDS) in Food & Supplies Department, Govt. of West Bengal, it is clarified that for payment of Transportation Assistance to the lifters-cum-transporters engaged in lifting and transporting MDM foodgrains/rice, the Nodal Officers in the Districts and Kolkata areas may follow the PDS rate of Food & Supplies Department, Govt. of West Bengal in terms of Order No. 303-FS/Sectt./Food/4P-13/2009(Pt-IV) dt: 22.01.2019 on the basis of distance covered within maximum limit of Rs. 150/- (Rupees one hundred and fifty) only per qtl.


