This is to bring to the notice of the Collector and District Magistrate, Vizianagaram & the Chairman of the District Selection Committee that the Commissioner, APVVP, Vijayawada has issued permission for filling up of the following vacant posts of Specialist Doctors and Duty Medical Officer on contract basis for Strengthening of MCH and Dist. Hospitals with NHM support vide ref. 4th cited.

- 1. Gynecology – 3 posts
- 2. Anesthesia – 3 posts
- 3. Duty Medical Officer - 1 post

Further it is submitted that the District Level Selection Committee headed by the Collector and District Magistrate as the Chairman, the DCHS as the Member Convener and the District Medical & Health Officer, Vizianagaram as the Member vide ref. 1st cited.

Further, it is submitted that, previously the Specialist Doctors and Duty Medical Officers were recruited on contract basis for Strengthening of MCH and Dist. Hospitals with NHM support. But, as some of the individuals have resigned to their contractual services, subsequently the above posts are fallen vacant and they are required to be filled up immediately. In the Dist. Hospital, Vizianagaram HDS meeting held on 17-08-2018 with the Chairmanship of Dist. Collector, Vizianagaram to fill up the vacant posts due to high deliveries at MCH, Vizianagaram.

As per the existing provision, if any suitable candidate is not available in a particular roster point, vacancy may be allotted to the next roster point to suit the candidate instead of going for 2nd notification. Therefore, the existing above vacancies can be filled up by the available and interested candidates on walk in interview basis under the interest of public and patient care.

IV. CONDITIONS ON APPOINTMENT :

The candidate selected and appointed on contract basis shall not be regarded as a member of the service in which the post to which he/she is appointed, is included, and shall not be entitled by reason only of such appointment, to any preferential right to any other appointment in that or any other service. The department or the person may revoke the contractual appointment or discontinue the contract by giving one month's notice in writing on either side. This contract would automatically cease to operate on lapse of contract period and both parties will be discharged of their respective obligations and liabilities without any formal communication.

TENURE : Initially for a period of One year from the date of joining in the Post.
