ORDER:

As per Government Orders issued vide references 1st to 3rd cited, a notification was issued vide ref 4th cited inviting applications through online to fill up SC/ST backlog vacancies by publishing in the Vizianagaram District NIC website and notice board of Collectorate, Vizianagaram. A paper notification was also issued in local telugu daily news papers i.e. Eenadu, Sakshi which was published on 23.02.2018.

On receipt of applications through online, certificate verification was under taken by calling for the candidates who applied through online

After certificate verification, provisional merit list was prepared post wise at the ratio of @1:3 based on the marks obtained in the prescribed academic qualifying examination and published in Vizianagaram District NIC Website and Notice board of Collectorate on 10.12.2018 inviting objections by 26.12.2018.

Certain objections have been received from the candidates on the provisional merit lists and those objections have been examined with reference to rules and Government orders and disposed off. Accordingly, final merit list has been prepared based on the marks obtained in the prescribed academic qualifying examination by the candidates in descending order and post wise.

The following candidates are provisionally selected by the District Selection Committee based on the merit and allotted to the offices shown against their names in the backlog vacancies as reported by the concerned unit officers for issue of appointment orders under **10(a) of A.P. State & Subordinate Service Rules.**

The above provisional selection is subject to the following conditions

1. The candidate has to produce all original certificates to the appointing authority regarding age, qualification, and caste/ community applicable to the post.
2. The candidate should submit a certificate of physical fitness certificate issued by the Civil Assistant Surgeon of Government Hospital in the prescribed form.
3. His/her character and antecedents are not such as dis-qualify his/her for Government employment.
4. The candidate is hereby informed that the appointment is purely temporary and liable for termination at any time without notice and without assigning any reasons there for. The candidate should report before the unit officer as indicated above for issue of appointment orders within 07 days from the date of receipt of this appointment order. If the candidate fails to report within the stipulated time, his/her allotment order will be liable for cancellation without any notice or information.
5. The pension of the individuals will be governed by the contributory pension scheme as introduced in G.O.Ms.No.653, 654 and 655, Finance (Pen.I) Department, Dated 22-09-2004. The individuals are not eligible for pension under A.P. Revised Pension Rules, 1980.

The Unit Officers concerned are requested to issue orders of appointment in favour of the above provisionally selected candidate and admit the candidate after verification of all required original certificates and also physical fitness certificate duly following the procedure in vogue.

The concerned Departmental Officers are directed to intimate the date of joining of the candidate to the District Collector, Vizianagaram immediately.
