

Notification under section 93(1) of the Right to Fair Compensation and Transparency in
Land Acquisition, Rehabilitation and Resettlement Act, 2013

Under sub-section (1) of section 93 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Collector, Vizianagaram hereby withdrawn from acquisition the lands specified in the Schedule below in respect of which Preliminary Notification issued in Proceedings Rc.No.2811/2018/G3 dt.21.12.2018 and published in Vizianagaram District Gazette No.VZM/245/ 2018/A8 dt.22.12.2018 under section 11(1), Ac.12.45 cts as being not required for establishment of Construction of New By - Pass Railway line between Gotlam and Nellimarla from Km.103500 to Km.112110 .
