WHEREAS, Arunachal Pradesh Disaster Management Authority in continuation to order No. SEOC/DRR&DM/01/2011-12 dtd 07/05/2021 & 15/5/2021, under Section 22(2)(H) of Disaster Management Act, 2005 has issued fresh order to prevent and combat the surge of COVID-19 in the state vide Order No. SEOC/DRR & DM/01/2011-12 dated 28th May'2021.

NOW THEREFORE, in continuation to this office order of even no dated 8th May, 2021, and 15th May'2021 and in pursuance of above Govt. Order and to contain the surge of COVID positive cases in Tirap District, I Shri Taro Mize, Deputy Commissioner-cum-District Magistrate, Tirap District, Khonsa in exercise of power conferred U/S 144 Cr. P.C. read with Section 30(1) of the Disaster Management Act. 2005 do hereby ordered to implement the Govt. Order No. SEOC/DRR&DM/01/2011-12 Dtd.28/5/2021 in Tirap District.

- 1. All shops and commercial establishment shall shut down at 02.00 PM on all days.
- 2. Restaurants, Dhabas and other eateries may entertain dine-in guest only up to 02.00 PM.
- Restaurants operating within a Hotel or Resort can allow outside guests up to 02.00 PM only after which only in-house guest of the Hotel/Resort may be given room service.
- Delivery of essential goods through e-Commerce for the whole day may be continue with observance of COVID appropriate behaviour.
- Cold storages and warehouses may continue after 02:00 PM and movement of commercial vehicles carrying goods to such storage units is permitted. However, sale counters, showrooms etc. attached to these warehouses or cold storages shall not operate after 02:00 PM.
- Pharmacies, Hospitals, Animal Cares Centres and Veterinary Clinics may operate without restrictions being providers of essentials and emergency services.
- All Govt. Offices shall function till 02:00 PM with 30% Group-C staff (on roster basis as prepared by HoD/HoO).
- 8. All Group A & B Officials shall attend office till 02:00 PM.
- The extended restrictions will not be applicable to following Essentials / Emergency Services departments:
 - District Administration, District Court, Police, Security Forces, Fire & Emergency Services, Home Department, Forest Department, Finance & Planning Department, Medical, Postal Services, NIC, Disaster Management Department, SDRF, Power, PHED, Food & Civil Supplies, Finances, Taxes, Treasury & Accounts, Urban Development, Bank/ATMs, IT & C, IPR, AIR and Doordarshan, Social Welfare Department including functioning of Women Help Line, Child Protection Services, LPG Services including their delivery, distribution and transportation, Prison related



- services, Postal and Courier Services, Municipal Services like cleaning and sanitation, Food Corporation of India Limited.
- (ii) Agriculture and allied activities, and ongoing construction works will be allowed subject to the contractor/owner ensuring adherence to COVID-19 appropriate behaviours. The Concerned District Task Force shall ensure that labourers already at the site are engaged and no new labourers are brought from outside. Further, transportation to and from the camp to the work site shall be arranged by the concerned contractor/owner.
- 10. Movement of goods/persons related to commercial and private establishments providing following essential services/commodities shall continue to be allowed: -
 - Shops dealing with food, groceries, fruits & vegetables, dairy & milk booths, meat & fish, animal fodder, pharmaceuticals, medicines and medical equipment.
 - Banks, Insurance offices and ATMs. (ii)
 - (iii) Telecommunications, Internet Services, Broadcasting and Cable Services, IT services.
 - (iv) Delivery of all essential goods including food, pharmaceuticals, medical equipment through e-Commerce.
 - (v) Petrol Pumps, LPG, CNG, Petroleum and Gas retail and storage outlets.
 - (vi) Power generations, transmission and distribution units and services.
 - (vii) Cold storage and warehousing services.
 - (viii) Private security services.
 - (ix) Industrial manufacturing units of essential commodities and Industrial Production units or services, which require continuous operation/process.
 - All establishments and personnel related to print and electronic media.
- 11. Marriages and religious functions will be only private affairs and be allowed with presence of maximum of 10(ten) persons. No reception parties will be allowed for post or premarriage functions.
- 12. Funeral / last rites related gatherings shall not be more than 10 persons.
- 13. All religious places shall remain closed till further orders. However, the religious head of a religious place or his representative may perform minimal religious rituals/prayers.
- 14. All public transport will be allowed to operate only upto 30% of seating capacity, with COVID-19 appropriate behaviour.
- 15. Auto Rickshaws, Cycle rickshaws and taxi shall operate with one driver and two passengers observing COVID-19 appropriate behaviour.
- 16. Pillion riding will be totally prohibited in two wheelers, except with women and children.
- 17. There shall be total ban on movement of individuals from 03.00 PM to 05:00 AM daily, except for exemptions to Emergency/Essential Services & Departments and those going for COVID-19 vaccination with proof of session/site registration.
- 18. In respect of areas not covered by this order, the containment measures specified vide order even No. dated 08.05.2021 and 15/5/2021 shall continue to remain in force.



- 19. This order shall come in to force with effect from 5 AM of 31st May, 2021 and remain in force until 05.00 AM on July 1 2021 or until further orders, as the case may be.
- 20. Any person/group of persons acting in violation of this order shall be deemed to have committed an offence punishable under Section 188 of the Indian Penal Code and relevant provisions of the Disaster Management Act. 2005.
