ORDER:-

Whereas prohibitory order under section 144 of Criminal Procedure Code, 1973 for depositing firearms by all arm-licence holder in Rewari district, in the respective police station or with the authorized arms dealer, have been issued so as to remove any apprehension of misuse of such firearms to intimidate or coerce or influence or threaten electors affecting the smooth conduct of Haryana Vidhan Sabha General Election-2019 in all three Assembly Constituencies in District Rewari in a free, fair and transparent manner.

And whereas it has already been ordered in the said prohibitory orders that only those licencees can retain their firearms who have been given exemptions by the competent authority.

And whereas further it has been made to appear to me that a large number of owners of licenced firearms have still not deposited their firearms in the respective Police Station or licenced firearms dealer on some pretext or otherwise.

Now, all the owner of firearms are again and finally called upon to deposit their firearms in their respective Police Station or licenced firearms dealer against receipt immediately.

Further, the date of moving the application for exemption (for Bank/Security/ATM/Cash Van Guard etc.), if any, cannot be open-ended, hence, they are also called upon to move their application of exemption from deposition of firearm immediately by applying with PLA, Room No.121 Ground Floor, Mini Secretariat, Rewari.

Application moved after the cutoff time and date shall not be accepted and considered by the competent authority.

IT IS NEEDLESS TO MENTION HERE THAT FAILUR OT COMPLY WITH THE DIRECTIONS IS PUNISHABLE UNDER SECTION 188 OF THE INDIAN PENAL CODE.
